



# Judge Advocate Philip C. Schiffman



You have requested the Judge Advocate of the Department of New York to render an opinion with respect to the following question:

May the Post Bar Chairman pay bar bills from the bar checking account?

Before answering the question, let me congratulate you and the members of your Post for taking the necessary steps to eliminate the Post Association. Having done so, I can assure you that you have eliminated a host of problems that would probably raise their ugly heads in the future. Second, let me congratulate you on running what is obviously a very tight "ship".

The Post member who raised the question of the propriety of the Bar Chairman paying from a bar checking account the bills of the Post bar, certainly had every right to do so. However, this is not in violation of the By-Laws, or Manual of Procedure of our National Organization.

Among the duties of the Department of New York

Quartermaster, as set forth in the Manual of procedure at Section 218 (5), that paragraph provides as follows:

"comply with, and perform all duties required of him by the Laws and Usages of this organization, applicable By-Laws and Orders from lawful authority and perform such other duties as are usually incident to such office."

Since, as you have indicated in your letter of May 22, 2004, the Bar Chairman gives a report to the membership on a monthly basis, and his books and records are audited by the Post Trustees on a monthly basis, and that this procedure has been carried out over a long period of time, it will do no violation to the VFW National By-Laws or Manual of Procedure, or the By-Laws of the Post, for the Bar Chairman to continue that practice.

Since the Bar Chairman is handling Post funds, it is strongly suggested that an average be taken of the amount of money that the Bar Chairman may be handling in any one (1) month, and that he be bonded for that sum.


Such a bond may be obtained through our Department of New

My special project will be "cell phones for soldiers". This is a project started by two young kids in Roswell, MA. The purpose is to raise enough money to eventually buy and put into use satellite phones for military personnel that have no access to landline phones.

We will collect unused cell phones and also copier and printer cartridges that can be sold for recycling as well as any cash contributions we receive from the members.

These two kids, Robbie and Brittany Bergquist, to date, have raised over \$110,000.00 for this project. They have enlisted the help of several firefighter associations and backing from former Buffalo Bills Quarterback Jim Kelly.

They have a law firm in Boston that is assisting pro bono in attaining 501(c)3 status with the IRS. They also are communicating with the White House for assistance in cutting through red tape to have a Saudi Arabian company begin setting up the satellite station. In the meantime, they are working with a Swiss company to put together a computer program for voice over messaging that can be used until a satellite system is in place.


The Remembrance Ceremony was held at the Inter Faith Chapel, located at Kings Point Merchant Marine Academy, Great Neck, NY.
