



#### Comrades,

Spring has finally sprung. It is certainly nice to see the green grass, flowers and enjoy the warmer weather.

It appears that the wisdom of your Department Leadership and their courage to make a number of difficult decisions early this year has resulted in financial stability and resulted in the control of the Department Funds. To date, April 30, 2006, there have not been any withdrawals from our line of credit; nor have we had to take funds from our investments to subsidize our income. At this point in time, the income from membership dues and the effort of our fundraisers are providing the funding to cover our dispersements. The question is, with 97% of the annual membership dues collected; will we be able to sustain the current financial performance through June 30, 2006? Based on the available information, it appears that we will.

Membership is a key to the Department's overall success in our programs, service to our veterans and finance. Many Councils need less than 100 members to be 100% as well as the Post who need less than 10 members to achieve 100%. Let's get out there and finish the job for our members and for the veterans we serve. Let's bring the Department 100% in membership. The National deadline is June 30, 2006.

At the Spring Conference, the State Commander, Line Officers and District Commanders were provided with the Third Quarter Summary of the Department Accounts, financial statements and related documents, respectively. As I promised when I was elected, a full disclosure of the Financial Status has been provided to date to our Department leaders with the expectation that they will circulate this information at the District Meeting to the District's Line Officers and through the Council to the Post and finally to every member of the Department that was interested. The changes in our financial program made our budget preparation process much easier this year, since we were using actual income and expenditures to prepare and complete the budget.

I want to thank members of the Department of New York VFW for allowing me the opportunity to serve this past year as the Department Quartermaster. I will be seeking the re-election to the Office of Quartermaster for 2006-07; and therefore, I am asking for your continued support at this year's June Convention.

'Leadership is actually what the OTI provides, so make every effort to attend this year. You will be glad you did."

Both the VFW and Ladies Auxiliary conduct their OTI schools at the same time at the SUNY campus using separate dormitories but joint dining facilities.

The school provides an exceptional staff of qualified instructors hw meet several times a year to assess the courses and teaching methods plus discussing student comments, which are requested at the conclusion of the school each year.

Cost of attending the OTI is \$95 per person, which includes two nights lodging, five full meals and classroom material distributed to each student. It is important to note that a Post can pay for members attending from the bell jar and relief funds. This has been ruled a legitimate expense for both of these funds.

Paying the student fee by this means should eliminate the cost issue but more important for new officers to take the course based on your office. The school offers full instructions on all three courses but students, of course, can only take one of the three and must register for their choice. The classroom teaching includes both lectures and many visual aids. Time is always allotted for questions.

Members attending should plan to arrive at the registration center no later than 4 p.m. to have time to get their room assignment and be ready for dinner. An orientation meeting will be held Friday evening (July 28) when the instructors and the State Commander will be introduced by Dean Garrett. Rules and regulations for the weekend will also be announced. When you drive into the campus, signs will direct you to the parking areas.

tion. At a recent POW/MIA ceremony held at Steward Air National Guard Base, Past State Commander Ben Thompson sent a message that is clear and precise. He asked us to "sing our own song." To sing the song for all to hear that we are veterans ands that we are tired of having to ask year in and year out for what is due the veterans of this wonderful country. Many who prowl the corridors of our nation's legislative halls seem to forget that they would not be there if it were not for the sacrifices of citizens who took up

It is always time for legisla-

arms to defend this great nation and the world at large. Ben has asked us to sing our own song so all will remember. Not a bad idea.

Two items that Legislative Vice Chairman Cliff Lockwood has asked we keep in mind and contact our state legislators about: 1 - A.8883-S.3027 - exempts compensation use taxes at gift shops located at NYS veterans homes and 2 - A.10488/S.7218 - Crime of disturbance of a funeral or memorial service, keep protestors 200 feet from a funeral or memorial service. Please contact Albany about these. I think the second one is especially critical. We cannot have this type of interference during funerals or memorial services. Contrary to the opinion of a few, there are some that are sacred.

Last, not wanting to step on the toes of our PAC Chairman Tim Kuhn of Richmond County, it is important that I mention some changes in the way that PAC will operate. This November, there will be elections that include every member of the House of Representatives and one third of the Senate. Each incumbent and each challenger will be sent a survey by the PAC. If they do not return it, they will not be considered for endorsement. While the determination of who to endorse will be decided ultimately by the National PAC Committee, they are looking for our input. We need feedback regarding these people.

Remember, sing the song of veterans; and if you cannot carry a tune, like me, take up our new weapon, the pen, to write your elected officials.

# Buddy Poppy Report for 2006 Spring Conference

With this year's Spring Conference a little later than last year, our Buddy Poppy totals have risen by more than 1,500 since last year's Spring Conference. As of April 18, 2006, total purchases for the Department of New York currently stands at 471,500, which is 73% of goal. With two months left, 650,000 is a feasible number with your help.

Moina Michael in 1918 proposed "Flanders Field Poppy Day," which eventually became our "Memorial Day." England has 60 million residents with a total of 40 million "English Poppies" distributed annually. The question of proper distribution – with England able to distribute over 66% of their citizenry while we in the United States cannot distribute to even 66% of our Veteran population. We, as Veterans of Foreign Wars, must bet out the word that "Freedom Is Not Free!" and Buddy Poppies may be worn by everyone to serve as a reminder of all Veterans who have died for preservation of our freedoms.

All Buddy Poppy orders must be processed through the Department of New York, VFW, with at least a 500 order recorded in order to be eligible for a White Hat for membership. Current cost for Buddy Poppies is \$130.00 per 1,000 and all proceeds are to be recorded in the Post Welfare Fund.

Increased numbers of Buddy Poppy sales indicates that your hard work is paying off. Department of New York thanks you for your efforts, but there is still a lot more work to be done. In order to reach our goal of 178,500, more Buddy Poppies must be purchased, which is more Buddy Poppies than were purchased for Veterans Day. Only with your assistance can the goal of 650,000 be achieved. I know you will help us achieve the goal of 650.000.

This concludes the Buddy Poppy 2006 Spring Conference Report.

# Life Membership

Through the end of April, you have transmitted 1,848 Life Memberships. You have all done an amazing job, and we hope you will continue through May and June. As you may know, National is trying to almost double the cost of Life Memberships. Last year, it was narrowly defeated; but this year, it may pass. That means it would take effect January 1, and you have until sometime in December to get all the Life Memberships that you can. For every one that you get, that is one less regular member that you have to get – ever again. It is also \$5.50 more that your Post will receive every September.

I urge ever Post to send out letters to each regular member explaining the proposed increase. We don't know who will be the Chairman next year but do it for yourselves. Send the letters July 1st. Get some bell jar money and offer to pay a portion of the Life Member's cost. It is legal, and it works ... and it may be the last time we can get Life Members at a reasonable price. Can you imagine an 85-year-old paying \$170 for his Life Membership, or a 55-year-old paying \$335?

### Important Alert for VA Customers Patients' Personal Data Stolen

WASHINGTON, May 22, 2006 – The Veterans of Foreign Wars of the U.S. is alerting all members that computer records with personal information on millions of veterans were stolen earlier this month from the home of a data analyst who works for the Department of Veterans Affairs.

In conference calls today with veterans, service organizations and with members of the national news media, VA Secretary Jim Nicholson admitted that up to 26.5 million names, social security numbers, dates of birth and, in some cases, home addresses, disability ratings and spousal information were stolen during what appeared to be a random burglary.

The VA employee, whom the secretary said was not authorized to take the information home, has been placed on administrative leave as FBI and local law enforcement officials continue the investigation.

VFW Commander-in-Chief Jim Mueller called the admission deeply disturbing, but said he would help the VA inform the 2.4 million members of the VFW and its Auxiliaries. Then he demanded accountability.

"What happened is absolutely unacceptable, but the task at hand is to inform every veteran family so that they can begin taking steps to safeguard their personal information," said Mueller, who then wants those employees and/or officials who may be at fault to be held accountable for their actions.

"Above all else, we demand accountability from those who work for the people," he said. "Whether the investigation reveals it was one person involved or includes others in more senior positions who may have given tacit approval, we expect their employment to be terminated immediately. The severity of this incident does not permit second chances."

Nicholson said the 26.5 million names represent every military veteran discharged since 1975, and possibly earlier if the individual filed a VA claim. He said that there is no indication that anyone's medical or financial records were compromised, but did acknowledge that the reason he decided to go public with the news was to alert all veterans of the incident and for them to be more vigilant of their personal information.

The VA will send out individual notification letters to veterans to every extent possible. Veterans can also go to www.firstgov.com <http://www.firstgov.com> for more information. Also, the VA has established a manned call center for veterans to receive information about this situation and to learn more about consumer identity protections. That toll free number is 1-800-FED INFO (333-4636). A special call center has been established and is open from 8 a.m. to 9 p.m. (EDT), Monday-Saturday, as long as it is needed.







# Mark 60th Anniversary Volunteers Donated 13 Million Hours Last Year

WASHINGTON – For as long as the United States has had veterans, the nation has also had men and women who volunteered to help in the care of the wounded, the sick and the injured.

But 60 years ago, a partnership was formalized when the Veterans Administration (VA) created an office to oversee the volunteers assisting at the agency's facilities. That office now has about 140,000 volunteers on its rolls, with 94,000 contributing more than 13 million hours last year. VA would have needed 6,200 employees to replace the time donated by the volunteers, at a cost of nearly \$228 million.

"Volunteers have always been at the heart of VA," said R. James Nicholson, Secretary of Veterans Affairs. "They free

our doctors, nurses and technicians for work that only a professional can do. They are visible proof, especially to our combat-wounded, that the nation deeply appreciates the many sacrifices of our veterans."

In April 1946, former General of the Army Omar Bradley, then head of the Veterans Administration, convened a meeting of veterans groups and welfare organizations to establish a national plan for volunteer assistance at VA facilities.

From that meeting grew the Voluntary Service Office that now works with more than 60 national groups to provide volunteers for the Department of Veterans Affairs.

"Our volunteers take your breath away with their spirit, selflessness and dedication," said Dr. Jonathan B. Perlin, VA's Under Secretary for Health. "Our health care system is immeasurably better for their priceless contributions."

Volunteers assist hospital staff. They work in nursing homes, hospital wards, clinics, recreational activities, endof-life care and many other programs. They also work in national cemeteries and benefits offices.
