Since taking office, I provide Quarterly Financial reports to the Department officers and Council of Administration for their information and so that they can disseminate it to their District, Council and Post membership. I will continue to provide these reports to provide the financial disclosure that the Department Line Officers and Council of Administration have come to demand. The Department's current investment strategy provides security and reasonable safe growth. I hope that our District Commanders have provided the financial information that they have been receiving this year to the County Council Commanders and the members that are interested in the Department Finances.

The National Legislative Conference was held in Washington, DC, March 3rd through the 6th. The Legislative Chairman Karl Rohde, myself, and Jr. Vice Commander Jack Haight spent Tuesday at the Congressional Building meeting with Congressmen and women presenting our legislative programs for both National and State. In addition, we met staff from our two Senators Chuck Shumer and Hilary Clinton regarding these legislative programs. You also need to know that we discussed the hot topic in the news regarding the abhorrent conditions that our returning veterans are experiencing at the Walter Reed Hospital. They have advised us that there is a fullscale investigation going on

cial changes. By supporting the changes required to improve our finances in a positive direction at the Legislative Conference, I recommended to the Council of Administration to increase the daily per diem from \$50 to \$60. By a motion properly made and seconded and passed, this increase was approved and was effective immediately.

I know that we speak of this often, but our Department membership is not good. We need everyone's help to reach out to those comrades that have not paid their dues. At this writing (4/2/07), the Department is down about 6,000 annual members. Now is the time for each Post Commander, Post Quartermaster and Post Membership Chairman to act. We ask that you call those in the Post who have not paid their dues. If they are ill or need assistance, the Post can pay their dues from the Post Relief Fund. If you cannot access your Posts' information from the National Membership Program, please contact me; and I will get that information for you.

I appreciate the support I have received from the Line Officers, comrades and Past State Commanders of the Department of New York during my tenure as State Quartermaster. It has been my pleasure to serve as Department Quartermaster since June 2005. As the State Quartermaster, I review and approve all disbursements, write all checks, make all deposits, and administer all of the financial accounts of the Department. More stringent controls have been placed on the Department finances during my tenure, which has resulted in better cash flow management and accountability. The Department has not had to draw against the line of credit or withdraw funds from our investments during my tenure. Conversely, we have had the opportunity to add funds to

concerning this.

As I stated in the last newsletter, our participation in legislative programs is a key part in making our representatives aware of the fact that YOU are a veteran and that they are aware of what veterans' needs are.

Regarding membership, we are now eight months into the membership year, and we need to work hard to make 100% this vear for Commander Doell. A Legislative Marathon has just concluded. Starting February 24th with the Albany Legislative Conference and ending with the conclusion of the National Legislative Conference on March 7th. The only problem with this race is the only way we will know who won is based on the legislative changes we will be able to help enact. If there are no positive changes for the veterans or our service members, then the Marathon will have been in vain.

On February 26 Commander Doell, along with Sr. Vice Commander-in-Chief Lisicki led a delegation of VFW and Ladies Auxiliary to the Hill. The "Martin Van Buren" room was packed to standing room only. Comrades and sisters had to sit on the staircase to get a seat; many stood for the one-hour testimony. A small group of Senators and Assembly members listened to the testimony, and they promised to take the information back to their colleagues. Significant were the remarks of newly appointed Chairman Vincent Leibell. The Senator stated that he had long sought this chairmanship and intended to put the "veteran back in the Veterans' Committee." After the testimony, the Senator asked me, as Legislative Chairman and Senior Chief to be on a 15-minute TV show with him regarding veterans' issues. At the conclusion of the show, he asked the Senior Chief if he could be invited to Washington, DC, to confer with the VFW on veterans' issues. The answer was yes, and a meeting will be set up next fall. The Senator's aggressive manner bodes well for the veterans of New York.

A few comments must be noted regarding the Reception at the Marriott Monday evening. There were some problems with the event. First, there was a seating problem that will be addressed as well as some consideration for the dietary of some of the attendees. People should keep in mind that this is not a 12-course meal. It is a

I will meet with our officers regarding this issue. It is hoped that the lack of participation was not because the various Posts, Councils and Districts failed to invite their Assembly members and Senators. New York State National Guard and Reserve Units

These brave service members must receive entitlements that are commensurate with their service to our country. That means the level of and access to health care must increase, as well as education entitlements. We would like to see our great Empire State taking the lead in this issue.

Expansion of Health Care

Expansion of Health Care such as nursing home facilities, assisted living facilities in supportive housing not now served. along with in-home care.

Homeless Veterans

OTI School for 2007 is Cancelled

Comrade Commander and Members,

The Budget Committee for 2007-08 met on May 7, 2007 at Department Headquarters to prepare the annual budget for next year. The committee was once again faced with many challenges to continue funding current programs, new initiatives, employee salaries, employee benefits and the many financial obligations of the Department. Many adjustments had to be made to the budget to accommodate the programs and obligations of the Department for 2007-08. I commended the Committee for not only making the difficult decisions this year but their consideration of impact of their action on the future financial progress of our Department.

One of the Budget Committee's many recommendations is the OTI Program for this year not be funded and therefore cancelled. The reasons behind the decision include first and foremost the cost of the Department to Staff this program and associated costs of funding this program. Additionally, the members of the committee concluded

many of the students have a long history of attendance at the OTI Course and there fewer new students. The cost to the student continues to rise and impacts attendance. The discussion included future OTI programs. The consensus of those assembled was that due to rising cost, the program should be offered every two (2) or three (3) years depending on available funds and membership interest. To fund this program in the future, it was recommended that the incoming Commander work with their State Legislator for a grant to fund this program as has been done in the past. The Jr. Vice Commander, State Surgeon and I concur and agreed with the committee's assessment that the OTI program for 2007 should be cancelled and that the program should be held every two (2) to three (3) years based on funding availability and membership interest. Therefore, the OTI School for 2007 is cancelled.

Buddy Poppy 2007 Mid-Winter/Spring **Conference Report**

Buddy Poppy acquisition by Posts have reached 280,500, which remains 369,500 short of the desired goal of 650,000.

There is no better way to display support for Veterans than properly distributing Buddy Poppies. Wearing a Buddy Poppy displays support for all Veterans while the mere ordering of Buddy Poppies help disabled Veterans receive compensation for constructing these Buddy Poppies.

Money received as donations for distribution of Buddy Poppies is used exclusively for Welfare Fund of Post's usage in assisting needy Veterans. Your assistance in increasing Distribution of Buddy Poppies is essential if our goal of 650,000 Buddy Poppy acquisition is to be accomplished.

In order to allow Department of New York to receive Buddy Poppy credit, all orders must be processed through Department of New York at \$130.00 per 1,000. If in position to receive a White Hate, a minimum of 500 Buddy Poppies are required purchased after all other requirements have been completed.

With Memorial Day approaching, your Post should be planning a day of Buddy Poppy distribution. Remember, if your Post requires Buddy Poppies, the approximate time for delivery is six weeks from day order was processed.

New Planning Opportunity for Those with IRAs

for you if you are:

- Age 70 1/2 or older
- Own an IRA, and
- · Regularly make charitable contributions.

The new Pension Protection Act of 2006 allows you to make distributions directly from your IRA to one or more charities without the distributions being included in taxable income and subject to withholding.

Previously, if you wanted to use IRA funds for a charitable contribution, you had to withdraw money from your IRA and then contribute it. The amount you withdrew was taxable, and the deduction for the contribution

Recent legislation offers a new opportunity may or may not have offset the tax. Another benefit of the new legislation is that the funds transferred from your IRA to a charity count towards your mandatory withdrawal.

These tax-free distributions can be made only until December 31, 2007.

The IRS Exempt Organizations Implementing Guidelines for FY 2007 (essentially IRS's work plan) states that the IRS will be targeting exempt organizations that conduct gaming activities because "historically examinations of {those organizations} ... have identified a high level of noncompliance." The IRS has picked ten states, which it has not identified, where they will look initially. The IRS has developed and will use a "gaming risk model" by which it projects the identity of entities with a "high likelihood of noncompliance." I think this somewhat confirms my prediction that the IRS will crack down on gambling. Posts need to have their ducks in order.

Additionally, the Guidelines indicate that IRS will be specifically targeting employment withholding and FICA compliance. This is another area where the Posts need to be careful.
