Past Chief George Lisicki was the National Representative for the Dept. of New York's Fall Conference.

George Lisicki, of Carteret, New Jersey, was elected Commander-in-Chief of the Veterans of Foreign Wars on August 23, 2007, at the VFW 108th National Convention held in Kansas City, MO.

George served in the U.S. Army from 1966-69. In Vietnam, he served with the 2nd Battalion, 35th Infantry, 4th Infantry Division in the Central Highlands near Pleiku. He was awarded the Bronze Star, Vietnam Service Medal, Vietnam Campaign Medal, Good Conduct Medal and the National Defense Medal among others.

In 1971, George joined VFW Post 2314 in Carteret, NJ where he became a Life Member in 1976. He was the first Vietnam Veteran in Post 2314 to be elected Post Commander, an office he held for four terms. He earned the title of All-American State Commander in 1988. George served as the New Jersey State Membership Director for nine years and the instructor for the New Jersey Officer Training Institute for 24 years. In 1995, he was elected to a two-year term as a VFW National Council Member. He has served as chairman for the National Security, POW/MIA and Legislative Committees. His other committee assignments include National Civil Service and Employment and Resolutions.

George is a member of the Military Order of the Cootie, The American Legion, Vietnam Veterans of America, Catholic War Veterans, 4th Infantry Association and 2nd Bn., 35th Infantry Association. He also serves as the chairman for the Carteret Veterans Alliance.

Jack Haight Department Commander

First, I would like to thank all of you that sent me cards while I was ill. I had cellulites, spent four days in the hospital and the remainder of two weeks in home care with visiting nurses. I also want to thank the Lyons VFW for the fruit basket. One of the nurses at the hospital was an Auxiliary member there.

I made an error in my last article. The Sampson Veteran's Cemetery is to be maintained by Seneca County and run by trustees of the cemetery association. We had State Senator Mike Nozzolio update the Council of Administration at our Fall Conference. There were about 750,000 sailors and airmen that took their basic training at the Sampson base. After the military left there in the mid 1950s, the land was given to New York State. Mainly through the Senator's efforts, a portion of the land (100 acres) has been set aside for the Veteran's Cemetery. Due to the closeness to the Bath National Veteran's Cemetery, it could not be a National Cemetery and because of State Law, it was by far better to have it run by Seneca County. The expected date of the first burial is Veterans Day 2009. There is already a waiting list, and it is open to any veteran that honorably served and his/her family member. On the shore of Seneca Lake, it is a beautiful spot.

The Auxiliary President, Cindy Campbell, and I would like to raise enough in donations from our members to purchase the flag pole, lights and plaque. The

plaque would state that the NY State Veterans of Foreign Wars and its Auxiliary made the donation. We need about \$4,000 each (The VFW and Aux). The Auxiliary is running a raffle for a Queensized quilt with WWII fighter planes on it. Tickets are \$1.00 for one ticket or six tickets for \$5.00. It will be drawn at the Spring Conference. Donations can be sent to the Department Headquarters earmarked "Cemetery."

We are also seeking donations to bring children from the National Home to our Convention in Buffalo next year. We would need approximately \$1,000 each (the VFW and Aux). Donations can be sent to the Dept Headquarters earmarked "to bring National Home kids to State Convention."

My Special project is the Fisher House and donations again can be sent to the Dept Headquarters. A report was given at the Fall Conference. Thank you for your donations.

It is hard to believe, but this year is already a quarter over. By now, you should be well underway with all projects. Refer to the Membership Program booklet.

You may notice that the paper is not as big as the last few. This is partially due to the economy. The OSV paper is paid for by one of our solicitors. Donations are down, mainly due to the economy.

Deputy Inspectors for the job they have done so far this year in getting inspections done in the Posts and County Councils. Try and get as

many done as early

as possible, before the white stuff starts flying. Also remember that District, County Councils and Post Commanders and Quartermasters need these forms to be completed to receive their white hats for an All-State award at the end of the year.

As of now, all County Commanders have received their Inspection forms in the mail. If for some reason they have been misplaced, you may also go online at www.vfw.org and www.vfwny.com for blank copies of the Inspection form that you can make copies of and fill out.

I have noticed on some of the Inspection reports coming in to me so far this year, that some Posts are not bonded. The National Bylaws, Article VII, Section 703 requires that each Officer accountable for funds or property be bonded in the proper amount.

The Commander of each Post, County and District is responsible for making sure this has been done. You may purchase a Bond each year through the Department of New York with the minimum bond of \$5,000 costing you \$25. You may also increase the amount of the bond with the

I attended the 109th National Convention in Orlando, Florida. An uninvited guest also attended the Convention namely tropical storm Faye and it rained for 10 days.

Emphasis was placed on programs rather than membership. Although membership is the backbone of our organization, many people are not familiar with the VFW programs. I visited the National Home on October 9 and 10, 2008. To operate the VFW National Home, the cost runs just under \$6 million a year. It is important that our donations keep coming in.

I met with three people: Tim Smith, Development Director; Todd Marriott, Facilities Director; and Susan Stevenson, Public Relations Director. Susan has been on staff for about four months. She will be promoting the National Home.

I also toured New York Houses, #1 and #2. There were no great concerns for the houses at this time. The family in house one will be moving out soon, as their program is complete. The house will be readied for the next family. New carpet will probably be installed at the cost of between three and four thousand dollars.

House #2, the residential house, has two children at the present time: a girl 14-yearsold and a boy who is 6-years-old. They could have up to six children, if the need arises.

The Fisher House is doing a great service to the Veterans and their families. As a veterans' organization, we

need to help them in any possible way we can. Hopefully, by the end of the year we will have word as to whether they are going to expand in the near future.

Below, I am providing a lot more information on the **Fisher House in Albany, NY**. I hope you will share this information with others so they will know that the Fisher House is there to assist veterans and their families.

Fisher House at Albany, New York

The Samuel S. Stratton Department of Veterans Affairs Medical Center at Albany is proud to be the first VA Medical Center in the nation selected as a site for the Zachary and Elizabeth Fisher House. It is a measure of the quality care given that Mr. and Mrs. Fisher chose this medical center to pioneer support to veterans and their families.

What Is Fisher House?

Fisher House is a home-away-from-home for families of hospitalized veterans or veterans who are in the area to visit a hospitalized member of their immediate family. Also welcome to stay at the Fisher House are veterans, undergoing an extended episode of outpatient therapy, who are able to care for their own personal needs or are accompanied by a caretaker.

Registration:

A waiting list is maintained. To register, contact the Fisher House Program Director at 518-626-6919. Patients or families may alternatively contact the patient's VA Social Worker. Referrals from the private sector are handled by the Program Director.

Registration hours are Monday through Friday 8:00 a.m. to 4:00 p.m.

Emergency requests are handled by the Administrative Officer of the Day; Ext. 66620 at all other times.

House Features:

• Accommodations: Two suites which sleep six each, five single rooms which sleep two or four each. Roll-away beds and port-a-cribs help with extra needs. Each room has a private bath, TV, clock radio and telephone.

• Occupancy: Seven families. When single individuals share a room, more families can be served at one time.

• Office: Located on the first floor.

• Common Rooms: Living room with fireplace and library, dining room, kitchen and laundry.

• Kitchen: Private locked cupboards keep food secure for each family. Built-in refrigerator and freezer store cold food which families label with their names.

• Food Provisions: Families provide most of their own

House Rules:

Families are responsible for their own rooms and cleaning up after themselves in the common areas. It is important to remember there is no maid service. Other important rules are no smoking, no alcoholic beverages or illegal drugs, no firearms and no pets. Quiet and mutual respect is also requested.

Group Living:

Families help each other in many ways. To adjust to life in the house, hospital and local community, new-comers get a helping hand from experienced guests.

They also exchange moral support in coping with the overwhelming stress of illness in the family. In this way, they serve as each other's extended family.

Eligibility:

The criteria which is evaluated to determine eligibility and priority are:

• Family members of the seriously ill or family members of the patient who is undergoing surgery.

• A veteran who is undergoing extended episodic outpatient therapy who is accompanied by a spouse or caretaker.

• Family members of a hospitalized veteran who are elderly and frail themselves, making travel a hardship.

Guests must be willing to abide by house rules and regulations including no smoking, alcohol or illegal drug use.

Background of the House:

The idea for a comfort home was presented to Mr. Fisher in 1989 by Admiral Carl Trost and his wife, Pauline.

The first Zachary and Elizabeth Fisher House was built at the National Naval Medical Center in Bethesda, Maryland in 1991. Mr. Fisher hired his own architect, builder and interior designer.

After the houses are completed, the Fishers turn ownership over to the respective Services or the Department of Veterans Affairs. The Fishers receive so much joy from the houses that more are being planned.

About Mr. & Mrs. Fisher:

Zachary Fisher left high school at age 16 to help his father and older brothers in the family construction business. Early in his career he suffered a severe knee injury in a construction accident, which prevented him from serving in the military. However, over the years, he and his wife, Elizabeth, served the country well by volunteering time and donating money to family-oriented military efforts.

In 1990, Mr. and Mrs. Fisher began the Fisher House program, dedicating more than \$20 million to the construction of comfort homes for families of hospitalized military personnel. Fisher House now operate at 17 military bases and at seven Department of Veterans Affairs medical centers throughout the nation and in Germany. More than 183,000 days of lodging are provided by Fisher House every year, saving families an estimated \$5 million annually. Since the program's inception, more than 65,000 families have stayed in Fisher House.

The Fishers were dedicated to enhancing the public perception of the U.S. Military and to helping needy members of the Armed Forces. They were true patriots who ardently supported a number of philanthropic activities. The Fisher House Foundation, Inc.* has established 32 Zachary and Elizabeth Fisher Houses, providing a home-away-from-home for families of hospitalized patients undergoing treatment at U. S. Military and Veterans hospitals. Their work is carried on by their nephew, Kenneth Fisher, who is chairman of the Fisher House Foundation Board. Mrs. Audrey Fisher and Nancy Edelman, both Fisher House Foundation Trustees, act as ambassadors for the Fisher House Foundation and visit each house annually.

Karl Rohde Legislative Chairman

Comrades, there is not much to write about because we have not had our Legislative Committee meeting to put together our statewide legislative priorities. They will be written at the Fall Conference in Liverpool. There is an interesting piece of legislation that should be looked into and that is the Military Personnel Citizenship Processing Act, a bill that curbs snags in background checks for Iraq and Afghanistan service members' citizenship applications. Senator Schumer is one of the supporters of this bill. I met with his staff a few weeks ago in Washington and they did not mention it. When you read this article, the election should be over. Please contact your re-elected or newly elected members of Congress with the National Legislative Goals. We had a great year for veterans this year in Washington – let's try to match it again. Please contact all your elected officials regarding the entitlements of veterans.

VA Health Care: The VFW calls on Congress to pass a sufficient budget for the Department of Veterans Affairs so that it can properly care for all of America's sick and disabled veterans. The VFW urges funding for the Department of Veterans Affairs to be sufficient, predictable and timely, ending the trend of the last decade wherein the VA's budget has been delivered months late. Congress must ensure that the unique health care and benefits challenges of OEF/OIF veterans are met, to include increased funding for Traumatic Brain Injuries and other related disabilities, as well as improved access to care, especially for veterans suffering from mental illness and for the growing number of women veterans accessing the system. The VFW calls on Congress and VA to increase priority given to women veterans by providing adequate services by hiring specialized health care providers and by providing training in gender-specific issues to help address shortfalls in gender-specific care and mental health care services for PTSD, Military Sexual Trauma and other needs. The VFW urges the Department to improve outreach so that all veterans are aware of the range of health care services and benefits available to them, especially with female, minority and rural veterans, who may be less aware of their rights than other groups of veterans.

VA Benefits and Compensation: The VFW asks Congress to provide adequate resources to enable the Veterans Benefits Administration (VBA) to reduce the current backlog of claims. To protect the needs of current and future veterans, the VFW opposes any changes to the current definition of "line of duty," structural changes to the programs for disability and survivors' benefits, or curtailment of veterans' or beneficiaries' rights of entitlement or to appeal benefit decisions.

Seamless Transition: The VFW demands a truly seamless transition for those men and women serving in uniform who are transferring from the Department of Defense to the Department of Veterans Affairs. We envision a system with a truly integrated electronic medical record that travels wherever the service member is stationed eventually to VA where it follows the veteran to wherever he or she receives health care. The VFW urges Congress and the Administration to improve the transition services and benefits provided to our veterans to ensure a steady and safe return to civilian life, including viable training, employment and education programs that address the realities of the current and future job markets to provide meaningful careers and not just temporary jobs.

As we enter another season we experience new and exciting challenges. The most recent challenge that faces many of our Posts is completing and filing their IRS 990 form by November 15, 2008. During the past two years we have provided informational seminars on this topic. The most recent presentation was made by the I.R.S. at the Fall Conference in Liverpool, New York. The information was very well received and provided many of our Comrades and Auxiliary members' very valuable information on the annual 990 filing requirements for non-profit organizations. As previously stated, the final filing date for this year's 990 filing is November 15, 2008. We hope that the information we have provided to you has helped make this transition a little easier and user friendly. For those Posts with gross receipts of less that \$25,000, you may file online at the following Web site address: http://epostcard.form990.org/

I.R.S. Annual Tax Return Filing

An annual income tax return (Form 990) is required of each Post exempt from tax under Section 501(c) of the Code. Gross receipts include income from all sources, including membership dues, liquor, hall rental, or restaurant receipts, etc. Some of this may be "unrelated business income," in which case filing of Form 990-T may be required. This return must be filed on or before the 15th day of the fifth month after the end of the Department's accounting period (period ends June 30, due date is November 15, 2008). Requests for extension of time to file may be made by submitting Form 2758, Application for Extension of Time to File. If a Post fails to file the return on or before the due date, or the extended due date, a penalty of \$10 for each day the return is late (not to exceed \$5,000) is imposed unless it can be shown that the failure to file was due to reasonable cause.

Factors that Effect Tax Exempt Status

Membership: The National Bylaws provide for only one type of membership; that is active membership. There are no provisions in the National Bylaws, nor is there any authority or justification for issuance of Club Membership cards, Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. Officers signing outlaw cards admitting nonmembers to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW Bylaws or procedures.

Incorporation: VFW Posts should take the necessary steps to incorporate under the laws of the state in which the Post is located. Financial responsibility laws, as interpreted by the courts, may cause members of unincorporated posts to be at risk. Incorporating under the provisions of sections 708 of the National Bylaws and the Manual of Procedure and the laws of the state will provide protection for Post members. Posts are urged to contact their Department Adjutant to obtain the proper forms for incorporating. The Articles of Incorporation must be reviewed by the Commander-in-Chief prior to forwarding them to the proper state authorities. Bonding: The attention of Post Commanders, County Council and District Commanders and inspecting officers is directed to Section 703, Manual of Procedure-Bonds. Each accountable officer of this organization shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which he/she may be accountable. Liquid assets are defined as cash on hand or in the bank and other negotiable instruments readily convertible into cash.

Electronic notice (e-postcard) for Tax-Exempt Organizations not required to file Form 990 or 990-EZ. You may click on to www.irs.gov and click the Charities and non-profits tab for more information. You may also call the IRS at 1-877-829-5500...<u>Remember filing</u> <u>Deadline For 2008 is November 15th 2008</u>. An Informational Seminar was held by the IRS at the Fall Conference October 17, 2008 for all the Comrades and Ladies of The Department of New York that were interested...You may have to consult a tax advisor the first year to see what form you might need...Do Not Lose Your Tax-Exempt Status...There are still many Posts that have not filed as of yet, and we are reminding them to do so.

As mentioned in the last news article of the *New York State Overseas Veteran*, you must register at least one Delegate from your Post for \$10.00 to the National Convention each year. Do Not Take a chance of losing your Post Charter for not sending your registration in.

Last year's total of 534,000 Buddy Poppies were ordered from the Department of New York which was 2,000 more Buddy Poppies than the previous year. At the Fall Conference in 2007, over 117,000 Buddy Poppies had been ordered. As of September 30, 2008, only 103,500 Buddy Poppies had been ordered, which is a shortfall of approximately 13,500 from last year at this time.

All funds received from Buddy Poppy distribution is to be used exclusively to assist our veterans through the Relief Fund. We are requesting your help to reach our goal of 700,000 Buddy Poppies for 2009.

The cost for Buddy Poppies remains at \$130.00 per 1,000 and you can also order a minimum order of 500 Buddy Poppies which is \$65.00. All orders need to be processed through the VFW Dept. of New York at 1044 Broadway, Albany, NY 12204.

Our New York City Regional Service Office is staffed by Nickla Culbert, Service Officer; and Ann Marie Bernard, Administrative Assistant. These offices provide services to those who have served, those who have returned and those currently serving in our country's armed forces.

The cost to properly staff and maintain these offices, so that the staff can provide these important services to our veterans, is approximately \$300,000 per year. The Department of New York is fortunate in that we do not pay for office space, heat, lights or telephone for these offices. The cost to the Department is the salaries for our staff and supplies required to maintain the operations. The funding for these employees

MAP Chairman's Report (continued from page 1)

This past year MAP contributed \$33,530 to seven events sponsored by Posts for veterans within our State. During fiscal year 2006-2007, MAP provided over \$634,488 nationwide in sponsorship of 234 projects.

Memorial Commendations are available through the MAP office for a service member killed in action. The Memorial Commendation comes framed and matted in the colors of the service member's branch of service and is intended to be presented to the service member's family by a VFW representative.

Operation Uplink

Through Operation Uplink, MAP provides pre-paid phone cards so service members can make that much needed call home when serving on foreign soil. Operation Uplink has connected over 8,500,000 active duty military and hospitalized veterans with their family and friends since 1996.

1,056,512 connections were made through VFW communication efforts in fiscal year 2006-2007. These include the distribution of phone cards and the Free Call days at 600+ Internet cafes in Iraq. Free Call days provide 24 hours of free calling at the cafes during holidays. I do have the scheduled Free Call Days for 2008-2009.

Both international and domestic cards are available and will provide 15 minutes of talk time and are valued at \$6.50 and \$1.50, respectively. All card requests should be made through me, your Department Chairman, and must include the unit designation, head count, and a POC. Since the program is funded solely by donations, the cards are limited to one per deployed every 60 days.

2007-2008 statistics for NY showed that 5,685 Domestic Cards were distributed with a value of \$13,897.74. In 2008, NYS Veterans placed 16,745 calls for 201,881 minutes.

Operation Uplink donations for the period June through September 2008 were \$20,224.50. A \$1,000 donation provides 154 VFW Operation Uplink phone cards which will provide a 15-minute call on AT&T phone banks or \$1,000 donation provides 25,000 minutes on a Free Call Day which will allow 1,667 fifteenminute calls. This provides 91% more connection time provided for the military.

The following activities were conducted from August through September under the auspices of the Military Assistance Program. 211 Domestic phone cards and 386 International phone cards were presented to VA Hospital patients and to members of our Armed Forces. 23 of the Domestic cards were sent to service members stateside by Edna Brown, Treasurer, Mayville, VFW Post 8647 Auxiliary. On 16 August 2008, 63 of the Domestic cards were presented by Bruce and Debbie Mullenax, from Scriba VFW Post/Auxiliary 9218, and Paul Dyer, North Syracuse, VFW Post 7290, VAVS Vice Chairman, to the 403 Civil Affairs Battalion personnel from Mattydale, NY who were enroute to Iraq via two month's of training at Ft. Dix. Comrade Dyer also presented 25 domestic phone cards to the patients at the Syracuse VA Hospital. The remaining 100 domestic phone cards were forwarded to Springfield Gardens VFW Post/Auxiliary 5298 in care of Shirley Jenkins, whereby members of the Post/Auxiliary conduct entertainment, provide refreshments and present phone cards to patients at St. Albans Naval Hospital.

35 of the International telephone cards were forwarded to deployed Service members by VFW Posts/Auxiliaries. These were Albertson VFW Post 5253, North

Steven Raiser, Command Judge Advocate for the 369th Sustainment Brigade in Harlem, NY requested information on grants to conduct Morale, Welfare and Recreation (MWR) activities for award ceremonies and for returning soldiers. Commander Bill Walden, VFW Post 3211, Hicksville, NY in regards to a grant in support of the 310 MP Battalion and Dan McMahon, Junior Vice Commander, Erie County Council, Grand Island VFW Post 9249 request for 25 International Cards to be forwarded to a unit in Iraq along with care packages. I am waiting for additional information prior to processing these requests.

Adopt-A-Unit

Our Adopt-A-Unit program is intended to forge a connection between VFW members and their local military community. Thanks to our Adopt-a-Unit program, Posts across the country can show support by adopting units and their families. By adopting a unit, the Post can establish and sustain a long term friendship with those serving stateside and abroad.

Posts can adopt stateside units close to their home and invite GIs over for dinner and/or games, while care packages, magazines and letters are all suitable to send to units stationed further away or overseas. Since the programs introduction in 2001, approximately 600 Post and Ladies Auxiliaries have adopted 578 units. Within our state, nine Posts out of 455 have adopted a unit.

But our efforts do not stop with military units. VFW members also remember the families left behind by offering ways to help out around the house, whether that's offering lawn care service, babysitting or free tax assistance.

Unmet Needs Program

Our Unmet Needs Program assists families of deployed or recently returned troops with grants. The funds can be used for rent, car repairs, medical expenses, infant care items and many other necessities. Since its inception in June 2004, Unmet Needs has received hundreds of requests for assistance. More than \$1 million had been disbursed to 702 families as of May 2006. This year, eight grants were given to UNMET Needs recipients for a total cost of \$13,897.74.

Through Unmet Needs, the VFW can provide grants up to \$2,500 to eligible service members and their families. Since the program began, Unmet Needs has assisted 1,146 families facing a hardship due to deployment or military service with \$1,640,308 in grant funds. For fiscal year 2006-2007, Unmet Needs assisted 355 families in grants totaling over \$562,000.

VetJobs

MAP has also partnered with an online job bank, VetJobs, designed specifically for veterans and employers seeking veterans. Resumé assistance and job listings are two key areas on this site. Tips on interviewing skills also are available. VetJobs offers this service free to veterans and their spouses.

Since the operation began in 1999, more than 80,000 Vets and their spouses have posted resumés; and 30,000 of those have found jobs through the Web site.

Melvin Garrett State Judge Advocate

Comrades, since the last published article much has happened in the way of amendments to the Bylaws, problems in our Posts and changes in leadership on different levels of the organization.

Example: Article 1 Members, Sec.109 Right of Appeal – Now includes the District Commander in the loop. Some Post officers and members are not following the oath of obligations and the provisions of the Congressional Charter in respect to their offices. The change in leadership, if elected, or if it should occur during the ensuing year, is spelled out in the VFW Bylaws and Manual of Procedure.

We are also experiencing many violations regarding the correct operation of the Post. It is extremely important that those comrades elected and appointed familiarize yourselves thoroughly with your duties.

We had many OTI's around the Department this year. I hope you took advantage of them in your area. As inspections take place, we need to know if there is a problem festering in the Post that should be addressed. Please don't sweep it under the rug, it could come back to haunt you in the future.

Don't forget to order a copy of the 2009 Congressional Charter from our National Headquarters; it will be very useful. After many warnings and continued violations, charters are being revoked for non-compliance of the Bylaws. They are not being returned, except on special consideration by National Headquarters. Call someone if you are having a problem, we are here to help you!

The Post Commander is directed to sections 708 of the National Bylaws and the Manual of Procedure, which prescribes the procedure for the Incorporation of Units. It shall be the responsibility of the Post Commander to ensure full compliance with both sections, and to ensure that all state requirements for annual filing, fees, etc., are met in a timely manner.

The Post Officers should obtain current copies of the podium edition of the national Bylaws, Manual of Procedure and Ritual. Copies of the 2009 revised edition of the Congressional Charter and Bylaws, Manual of Procedure and Ritual are available through the VFW Emblem and Supply Department, National Headquarters. The 2009 revised edition reflects the amendments adopted by the 109th National Convention, which became effective on September 20, 2008.

Post Commanders are reminded that Section 709, Manual of Procedure-Control of Units, requires that any activity, unit- or club-sponsored, conducted or operated by, for or on behalf of a Post, County Council, District or Department shall be at all times under the direct control of such Post, County Council, District or Department and that all money, property or assets of any kind must be placed in the care and custody of the respective Quartermaster. All Commanders should ensure that all provisions of Section 709 are enforced.

Each year the Department of New York sells ads in a Journal for the Gold Chevron Ball. The monies raised are used to pay the Department Service Officers and the members of their staff.

Last year gross receipts for the GCB Journal were \$13,605, an increase of 8.3% over the previous year. However, this is not enough! The income generated by three districts actually declined by 13.6%, 32.8% and 41.5%. It is a sad commentary that comrades and sisters cannot get out and sell an ad or two to support those veterans who need the help of the Department Service Officers and their staffs.

Most of the income generated by the Journal came from ads purchased by Posts, Auxiliaries, Councils and Departments. While I do not want to discourage purchasing of ads from within the VFW, we need to promote sales of ads to commercial advertisers. Taking money from one pocket to put it in the other seems silly. Each Post and Auxiliary needs to reach out to those with whom they do business, as well as businesses within their communities. If you have a Post home, who do you buy your heating oil from, your canteen supplies, your insurance? Ask them to purchase an ad and go into the local grocer, auto dealer, barbershop, etc. and do the same.

As an added incentive to bring in more commercial ads, the committee voted that for each commercial ad a Post or Auxiliary sells, they will receive one entry into a drawing for \$100. The size of the commercial ad sold does not matter. Each ad sold will equal one entry. The drawing will be held during the Department meeting in February.

Please get out there and sell the ads. Remember that the VFW motto is "**To Honor the Dead by Helping the Living**." Explain to those whom you approach what the Service Officers do to help the vets. I know they will be generous; they just need to be asked.

Mr. Tollis was a B-24 pilot during World War II, who was shot down by German fighters. Although he bailed out, he got tangled in power lines about 20 feet off the ground and was injured when he dropped to the ground. Mr. Tollis was subsequently captured and turned over to the SS, Hitler's Elite Guard.

Although the SS starved the flyer while in solitary confinement, they eventually relinquished him to the Luftwaffe, the German Air Force.

Mr. Tollis was then shoved into a boxcar with 40 other airmen, dined on black bread and water, stopped at Berlin which was under RAF attack, and then arrived with fellow prisoners-of-war at Stalag Luft I, at Garth, Germany where he spent the next 16-1/2 months.

The Lima man was finally liberated by Russian forces in May 1945 and flown to France and then the United States by the U.S. Air Force.

Two years ago, Krista Gabarro and Anna Eisenstein, students at Carmel High School, attended a monthly meeting of Brewster Post 672 and presented their vision for a handicapped-accessible nature trail. The trail would be located on land owned by the Putnam County Land Trust in the Town of Southeast. They presented us with a bold vision that they planned to accomplish over the next two years.

The final goal was a trail where persons without fine motor skills, using walkers and even those who were in wheelchairs could commune easily with nature. Mapping out the location was easy. Once they did that, however, it was an uphill climb. Sweat equity clearing the underbrush, moving rocks and fallen trees to insure that the path would be wide enough to accommodate two wheelchairs passing each other along with pull-off areas, although exhausting, was relatively easy. The difficult parts were fundraising, getting services donated and assuring that the trail was ADA-compliant.

With a projected budget of \$15,000 looming over them, the young women showed us their vision for the Lindera Loop Trail. Bringing with them photos of the area, both before and after their initial clearing efforts, along with enthusiasm and a drive to succeed that was apparent to all of the members present, they asked for our financial help. Post 672 donated \$2,500 - the first donation they received.

After two years of fundraising, donated labor and hundreds of hours of sweat equity on the part of the two young women, the trail was dedicated on September 20, 2008. The trail is open to the public and is a beautiful walk for those without handicaps and opens a world of nature to those who heretofore have been unable to navigate a walk in the woods.

Post 672 salutes Anna and Krista for giving the residents of Putnam the first handicapped accessible trail in the county. At the dedication, Krista and Anna presented a certificate of thanks to VFW Post 672.
