2009 Legislative Conference

Two Legislative Conferences have passed since the last issue of the Overseas Veteran one in Albany and the other in Washington, D.C. The VFW has advised our elected officials about the issues that are most important to veterans.

The State Legislative Conference was a great meeting. We stormed the hill and presented the New York State VFW Legislative Agenda to a joint meeting of the Senate and Assembly Veterans Affairs Committee. The conference room was packed with few vacant seats. The officials in Albany were able to see first-hand the strength of the VFW. Remember there is power in numbers. Past Commander-in-Chief Paul Spera spoke to the gathered legislators and reminded them of their responsibility to our nation's veterans. He also thanked them for what they had accomplished in the past year on behalf of New York's veterans. Auxiliary President Cindy Campbell, National Rep Leanne Lemley and State Ladies Auxiliary Chairman Marlene Webster all addressed those assembled. State Commander Haight asked the Legislators to listen intently to the VFW Legislative Agenda because it is a vital document that spells out the needs of the veterans of this great state. It was then my honor to present the agenda to our elected representatives for the sixth time. Following the presentation, the comrades and sisters of this great Department took time to visit their elected officials and talk up our agenda.

The beginning of April found me on a train bound for Washington, D.C. for the National VFW Legislative Conference. In the past five years, I have traveled to this conference on various different means of conveyance. and each time it is always a thrill to go to our nation's capital. Joining me for a second time on the newly expanded Legislative Committee was two past State Commanders: Mel Garrett and James McNally. On Sunday we had a busy schedule of workshop meetings that honed our Spera, State Auxiliary President Cindy Campbell and National Auxiliary

To all my chairmen, I give a "Well Done." I know they have worked very hard, and at this point, are still working. To my hospitality crew, one more event to go.



Hope to see you at the State Convention.



Comrades, the beginning of April is already past, and Post, County and District Inspections are still coming in. There are still 144 Posts, 11 County Councils and 5 Districts that need to be inspected. Each Post, County, and District is required to be inspected each year. Let's try and get them done before June. All Post election reports are

due at National Headquarters by June 1, 2009. Failure to do so may result in the suspension or revoking of your Post Charter. You can either fax (1-816-968-1149) or mail the report to National Headquarters, Attention: Kevin Jones, 406 West 34th Street, Kansas City, MO 64111. Do not forget to send a copy to Department of New York Headquarters, Attention: Art Koch III, 1044 Broadway, Albany, NY 14202.

Post Quartermasters – Section 222 of the National Bylaws require that each Post register at least one delegate to the National Convention in the amount of \$10.00. Try and get these done early. Do not take a chance of losing your Charter.

New Post, County and District Inspection Forms for 2009-2010

The new Inspection Forms are being printed at National Headquarters sometime in April. These new Inspection forms are lengthier, and more detailed. Some of the changes you will find are under Post Funds, All Other Account Types: for instance Bell Jar, Bingo, Bar Account, etc. Also under the Post Quartermaster: date of last IRS 990 filing, along with a question regarding if the 990 form is available for public inspection. Does the Post own real property, and the name of the Title Holder. You must also have your Employee Identification Number (EIN).

Mail Inspection Reports to: Veterans of Foreign Wars of the United States, Department of New York, 1044 Broadway, Albany, New York 12204. They will be stamped and dated at Department and then sent to me for comments. In the event some are mailed to my address, you will still be credited.

The Fisher House works on a first-come, first-served basis. A veteran who lives outside a pre-determined distance from the hospital but receiving treatments and not admitted as an inpatient of the VA Hospital, can stay with their family at the Fisher House at no cost. The same can be said when a veteran who is an inpatient at the VA or the neighboring hospital; their families can stay at the house at no cost. There is no limit as to the amount of time they can stay, as long as there is a need.

I left the Fisher House with a feeling which cannot be expressed properly in writing. Not only can these worthy individuals stay for free, but the house is more like their own homes with all the services they are offered. If you have never been to the Fisher House, I encourage you to take a few minutes out and visit Jerry Jensen (house manager) at the Fisher House and I am sure he will proudly give you a tour just like he did with our group.

At the Department Convention in June, I will be available to answer any questions about the Fisher House and I am hopeful to have some literature and contact information from the Albany Fisher House. Even though our year is winding down and the new Commander may have a different Special Project, it doesn't mean we should forget about the Fisher House. Donations can be made right to the Fisher House. Please keep this in mind because every day more and more veterans, both young and old, are in need of the VA system and the help provided to them and their families by the Fisher House. It has never been needed more. Again, thank you for your support this year.

To-Do List Before Department Convention

There are some very important things that your Post and county council must financial status and looking for ways to save money. A good investment for any make sure is done this year before we get to June and the Department Convention. Post, council and District this year is to send your officers and delegates to the State The first and foremost is each Post Commander should make sure a 2009-10 Convention to represent you and your wishes. ection report has been filed for the Post with both the National Organization and a copy filed with the Department of New York. The one you send to the Department of New York should arrive at least 30 days before the State Convention so the members of your Post are represented at the Convention through your Post, council and district delegates. If your Post files an election report late, it would be a good idea for the Post Commander or Delegate to bring a copy with them to the Convention. Last year at the State Convention, many members and Posts were not represented during the voting because an election report for the Post had not been filed prior to the convention.

The second thing that is very important is registering at least one delegate for the VFW National Convention. It only costs your Post \$10.00 and it is a requirement according to our Bylaws.

New Navy Commissary Grand Opening

Gene Ratigliano, Commander of VFW Post 420 in Saratoga Springs, reported that he received a flyer for the grand opening of the new Navy Commissary in Saratoga Springs, New York on April 4, 2009 (9:00 a.m. ribboncutting ceremony).

The Commissary in Saratoga will take the place of the one now located on Route 5 in Scotia, New York. An Exchange (PX to the Army and Air Force guys) will be under construction in the next couple of months, as well. I thought many of the VFW members in the vicinity might like to know of the relocation and grand opening.

Veterans Upward Bound (VUB)

Post-secondary education is not specifically set up for non-traditional students, such as most former or current military service members. After spending several years serving our country, many veterans realize the importance of getting their education. However, not having been in an academic setting in years, many veteran's wind up avoiding college. It is important to have a support group and some academic assistance as the veteran adjusts to school once again.

The Veterans Upward Bound program is a **FREE** U.S. Department of Education program created to help veterans refresh their academic skills and give them the confidence they need to successfully receive a college degree and pursue a career.

LaGuardia Community College's Veterans Upward Bound program is one of only 39 colleges and universities across the United States (and the only one in the tristate area) funded by the U.S. Department of Education to help veterans prepare for college.

The classes are non-credited and designed to focus on short-term remedial/refresher college prep classes. We offer a range of services designed to prepare veterans for success when they enter their chosen educational program, whether it is a two-year community college, a four-year college or university, or a public or private vocational or technical school. This includes assisting veterans in applying to the college of their choice, offering assistance with financial aid, academic advice, career counseling and assistance in obtaining veteran services from available resources, including the VA. Classes currently run in the evenings on a six-week schedule. For more information and to find out if your eligible, please contact Ms. Edith Segovia at 718-482-5231.

Since my last report, I have been kept busy fulfilling requests supporting the Adopt-a-Unit program, Memorial Commendations, Operation Uplink Telephone Cards and a request from an elementary student who wanted to provide a Penny Harvest Grant to Operation Uplink.

North Syracuse Post 7290 adopted the HHC, 527th Brigade Support Battalion, 27th Brigade Combat Team from Syracuse, New York. The Post made a commitment to support not only the troops with care packages, but on the local level to offer support to the dependents left behind when their unit deploys. I thank Post 7290 for building a relationship with your adopted unit.

Twenty telephone cards were forwarded to Dan McMahan from Grand Island Post 9249 for presentation to service members from Camp Phoenix and FOB Lindsey. Nationwide, 10,448 telephone cards were forwarded to service members during the February/March period.

There were 202,507 telephone connections made during this period. Of these, 191,949 connections were made during the free call days of February 14 and March 15 amounting to 2.3 million minutes of talk time. The next call days are May 10, June 21 and July 4.

Department of NY donations for Operation Uplink were \$7,639.64.

Under the Military Assistance Programs, 46 events were conducted consisting of 39,550 attendees and involving 29 Departments.

Nationwide, we had 50 casualties during the period with 35 requests for the Memorial Commendation. In our Department alone, we had eight of these requests. I offer my condolences to the families and friends for their loss. God bless them and all their families for their sacrifice toward the greater good.

The Unmet Needs Program provided support to 90 families amounting to \$144,008 nationwide. 123,907 military members and their families were supported through your hard work with National Military Service Programs.

The Common Cents Penny Harvest grew from one child's desire to feed the homeless, and the past 17 years, children between the ages of 4 and 14 have been converting their natural compassion for others into action by collecting pennies and turning those pennies into grants for community organizations.

This year, students from Ms. Danielle Lichtenstein's 4th- and 5th-grade class at Nathaniel Woodhall Elementary school considered a grant to Operation Uplink. The request was made for information on Operation Uplink by 4th-grade student Ormandy Martinez to Ms. Ferguson, VFW Manager, Special Programs and Projects. Ms. Ferguson thought this would be a great opportunity for a VFW representative to talk to them. After receiving Ms. Ferguson's e-mail, I contacted Queens County Council Commander James Blount, who visited the class on Tuesday, March 31. Jim, along with his officers, gave a presentation that was well-received. They were all invited back.

Thank you, Jim, for a job well done.

Memorial Day Sunrise Services

VFW Post 7955 will be hosting Memorial Day Sunrise Services at 5:45 a.m. on Monday, May 25th. Post members will be joined by members of The American Legion Post 1160, local elected officials and spectators as they travel to 13 locations (War Memorials or cemeteries) in the Towns of Ancram and Copake, NY. At each location, a prayer is offered followed by a rifle volley, then by *Taps*.

With the economy in a major tailspin more than ever, every Post Relief Fund is going to be challenged with members needing assistance throughout this great state. The sole purpose of issuing Buddy Poppies is to assist in maintaining your Post Relief Fund for just these trying times. However, in recent years the number of such distributions has been declining, with this year down from last year's totals.

Buddy Poppies are made by disabled veterans who work as a form of rehabilitation and for a small financial increase in their pockets. This program is designed to help producers, Posts and members in dire need. Your assistance in having Posts purchase Buddy Poppies will help your state, district, county and Posts plan to assist needy members of the Veterans of Foreign Wars to get over these rough times.


Incentives have been initiated by National to possibly get states, districts, counties and Posts to build a stronger Relief Fund. A rebate is given to districts and counties based on the number of Buddy Poppies ordered within their respective echelon.

Any Post that has a potential of reaching 100% in membership and earning a white hat, must purchase Buddy Poppies in order to be eligible to receive a white hat. As you can see, there are incentives on every level, yet a reduction in purchases of the Buddy Poppies continues.

534,000 Buddy Poppies were ordered within the Department of New York in 2008. As of **January 31, 2009**, only **226,000** Buddy Poppies have been ordered, which is 35,000 poppies behind last year at the same time.

Remember, send your Buddy Poppy order to Department of New York HQ, 1044 Broadway, Albany, NY 12204. The cost of Buddy Poppies are \$130.00 for 1,000 Buddy Poppies and \$65.00 for a minimum order of 500 Poppies.

Please help us reach our goal of 700,000 Buddy Poppies.



Patriot's Pen Essay Contest

The end of the year report from State Chairman Michael Spellman is as follows: There were 62 Posts and 31 Auxiliaries participating this past year in New York's Patriot's Pen Contest. From those Posts and Auxiliaries, there were 2,329 students participating.

There was a total of \$16,418.00 in awards presented by the Posts and Auxiliaries. Additionally, \$700.00 in awards were presented to students from county councils and \$2,441.65 in awards were presented by Districts. All eight Districts participated and the state awards were listed as: 1st place, \$500.00; 2nd place \$300.00; 3rd place, \$200.00, with each of the remaining District winners receiving \$100.00 each.

We have three months left in this VFW year to complete your goals and those set by our State Commander. Let each of us make one last effort to bring the membership of your Posts, County Councils and Districts to 100% and complete the programs outlined in the Department Membership Program. Please remember All-State Awards will be awarded based on Membership and programs received with a May 15, 2009 postmark.

Post Commanders, as you complete the Post Election process it is important that your Election Report is completed and submitted so that the National Organization can mail your Membership Kits! Post Election Report forms were mailed to Post Quartermasters with instructions that they complete and return the forms directly to National Headquarters immediately following the election of Post Officers, but not later than June 1, 2009.

National will begin mailing Quartermaster's Membership Kits to those Posts who have submitted their completed Elections Reports. The weekly mailing will begin in May and are expected to be completed by the end of June 2009.

Membership Kits will include membership applications, benefit brochures and a disk containing manuals and forms. A hard copy of the Quartermaster Manual will not be provided in the Post Quartermaster Membership Kit. LIFE MEMBERSHIP PAYOUT. As described in the National Bylaws it has been determined that, for the 2010 membership year, the Life Membership Fund will pay out \$2.84 for each Plan A, B and C Life Member, \$3.67 for each Plan D Life Member and \$9.00 for each Plan E Life Member to their Post, Department and to National Headquarters. Payment will be made in September 2009 for all Life Members recorded as of August 31, 2009. In addition, \$9.00 will be paid in January 2010 for each Life Member processed from September through December 2009 (Plan E) to their Post, Department and to National Headquarters.

The Internal Revenue Service has implemented new requirements for filing the Annual 990 tax form. These requirements necessitate the inclusion of policy statements for all levels of our organization. The new requirements also include questions about non-financial issues within our organization. We are currently preparing said policies for adoption by the Department. Additionally, we are addressing the non-financial questions which are now a part of the revised 990 tax form. Department of Veterans Affairs Data Theft Litigation

On January 27, 2009, VA agreed to pay \$20 million to settle a class action lawsuit filed after a computer, containing personal information on over 26 million veterans and family members, was stolen from the home of a VA employee. The money, less costs and attorneys fees, will be used to pay claims from veterans who can show that they suffered harm as a result of the theft.

Although VA eventually recovered the computer and the FBI stated that the confidential information had not been compromised, thousands of veterans purchased data security monitoring services; still others suffered emotional distress as a result of the theft.

The settlement was approved by the Federal Judge assigned to the lawsuit on February 10, 2009. The attorneys for the plaintiffs (VA) have stated that they will publish public notices describing the claims process. The ruling stipulates that payments will range from \$75 to \$1,500 for veterans who incurred expenses for credit monitoring or physical symptoms of emotional distress.

MIAs Returned to New York

KOREAN WAR IS IDENTIFIED: Cpl. Steven Lucas, U.S. Army, of Johnson City, NY was identified July 8, 2008 and will be returned to his family for burial with full military honors on July 11, 2008 in Arlington National

SOLDIER MISSING IN ACTION (MIA) FROM THE

Cemetery near Washington, D.C. In late November 1950, Cpl. Steven Lucas was assigned to the Heavy Mortar Company, 31st Infantry Regiment making up part of the 31st Regimental Combat Team (CT), then engaging enemy forces east of the Chosin Reservoir near Kaljon-Ri, South Hamgyong Province, North Korea. On November 29th, remnants of the RCT began a fighting withdrawal to more defensible positions near Hagaru-ri, south of the reservoir. Cpl. Lucas never made it to the lines at Hagaru-ri and was last seen on November 30, 1950.

MISSING WWII AIRMEN ARE **IDENTIFIED:**

2nd Lt. Irving Schechner, of Brooklyn, NY was one of 11 U.S. Servicemen, missing in action from WWII, that have been identified and returned to their families for burial with full military honors.

On December 3, 1943, Lt. Irving Schechner was part of the crew of a B-24D Liberator that departed Dobodura, New Guinea, on an armedreconnaissance mission over New

Hanover Island in the Bismarck Sea. The crew reported dropping their bombs on target, but in spite of several radio contacts with their base, they never returned to Dobodura. Subsequent searches failed to locate the aircraft. Three hunters from Papua, New Guinea came across the aircraft wreckage about four miles from Iwaia Village. AIR FORCE PILOTS MISSING FROM THE VIETNAM WAR ARE IDENTIFIED:

Capt. Gomer D. Reese III of Scarsdale, NY, one of two U. S. Servicemen missing in action from the Vietnam War, has been identified and will be returned to his family for burial with full military honors in the Spring of 2009, in Arlington Cemetery, near Washington, D.C.

On April 24, 1970, Capt. Gomer Reese was flying a U-17B light aircraft on an orientation flight over Xiangkhoang Province, Laos. The aircraft was struck by enemy ground fire, crashed and burned. U.S. aircraft in the area flew over the crash site and did not see any movement or receive any beeper signals or radio transmissions. In 2007, a joint team excavated the crash site and recovered human remains and crew-related items. In the spring of 2008, a team completed the excavation and recovered more human remains.

SOLDIER MISSING IN ACTION (MIA) FROM THE KOREAN WAR IS RECOVERED AND IDENTIFIED:

Sgt. Stanley E. Baylor, U.S. Army, of Webster, NY was recovered and identified Feb. 17, 2009. He was a Korean War POW-MIA. He will be buried Aug. 1st in Warsaw, NY with full Military Honors.

Sgt. Stanley E. Baylor was assigned to Company L 3rd Battalion, 8th Cavalry Regiment, 1st Cavalry Division. On November 1, 1950, the 8th Cavalry was occupying a defensive position near Unsan, North Korea in an area known as the Camel's Head, when elements of two Chinese communist force divisions struck the 1st Cavalry Division's lines, collapsing the perimeter and forcing a withdrawal. The 3rd Battalion was surrounded and effectively ceased to exist as a fighting unit. Baylor was reported missing on November 2, 1950 and was one of more than 350 servicemen unaccounted for from the battle at Unsan.
