Thomas Tradewell was elected Commander-in-Chief of the Veterans of Foreign Wars on August 20, 2009 at the VFW 110th National Convention held in Phoenix, Arizona. Tradewell served in the U.S. Army from 1966-1968

and earned VFW eligibility while serving with B Company 26th Engineers 198th Light Infantry Brigade (Americal Division) in South Vietnam as a demolition specialist. His decorations include the Vietnam Service Medal, Vietnam Campaign Medal, Purple Heart and Good Conduct Medal.

Tradewell joined the VFW in 1968 at Post 6498 in Milwaukee where he is a Life Member. He has served in elected and appointed positions at the Post, District and Department (state) levels culminating with his election as Department Commander 1999-2000. He served as National Inspector General in 2001-2002. He also served as the District 11 National Council representative for members from the Departments of Wisconsin and

> Iowa in 2003-2005. Tradewell earned an associate's

degree in industrial safety. Tradewell retired from Briggs and Stratton in 1998 as a Metallurgy Laboratory Technician after 30 years of service.

He is a member of the Military Order of the Purple Heart, Military Order of the Cootie, The American Legion, Disabled American Veterans, Vietnam Veterans of America and Combat Veterans Motorcycle Association.

First, to the National Convention in Phoenix, Spring and Fall Conference, Eastern States Conference in New Hampshire and many


Department meetings. I have attended many Post banquets and have met some real oriented VFW members.

### Return the Favor Campaign

Dear Comrades and Supporters:

A few days ago, I sent you a message informing you that the VFW Foundation was applying for a \$250,000 "Pepsi Refresh" grant to support VFW's "Return the Favor" campaign at the highest grant amount (\$250,000) in the next open period (April 1, 2010).

As I explained previously, we have launched this campaign so that we can continue providing the resources to support the unmet needs of our service members and their families and programs designed to boost the morale of active duty troops and their families.

Since 2004, the VFW and its Foundation has provided over \$3,400,000 in direct grants to military families for unmet needs such as rent, mortgage, utilities, vehicle repair, medical expenses and food/basic aid. In many instances, our intervention has stopped evictions and foreclosures on homes owned by troops and their families. We also hold numerous "welcome home" or "sendoff" events for our troops, so that they know that America truly cares and is thankful for their service.

Here is how you can help:

Starting on April 1 (at 12:01 a.m.) you can go online to www.refresheverything.com and vote for VFW's "Return the Favor" project. Click on the "Food and Shelter" category, and then the "\$250,000" grant level. You will find VFW's "Return the Favor" idea, pictures and a YouTube Video about the VFW, its programs and a description of our proposal which begins with, "Return the Favor to troops and their families for urgent unmet needs."

Remember, the projects that receive the most votes will be awarded grants from the Pepsi Corporation. Please vote and vote often for our project. You can vote once every day for our project during the month of April. You can help the effort even more by telling your friends, family and colleagues about our proposal and encouraging them to cast a vote our way. With the weather finally breaking from this harsh winter, which our entire country has experienced, it is time to consider hardships of others and how we can assist in making their lives a little less stressful.

The Buddy Poppy Program is designed to help everyone connected with the Buddy Poppy project.

Disabled Veterans are able to actually construct these flowers, making them useful in society rather than rely solely on others for their survival.

Distribution of Buddy Poppies by your Post provides income for your Post Welfare Fund, which is designed to help members and their families who are in distress.

Your County and District are recipients of a small monetary gain based on the number of Buddy Poppies purchased by the Post within their jurisdiction.

With such positive items looming on acquisition of Buddy Poppies, why does the number of Buddy Poppies continue to decline?

At the end of February, 282,500 Buddy Poppies have been purchased within the Department of New York jurisdiction, which is 417,500 away from our goal of 700,000.

In order to be eligible for white hat status, a minimum of 500 Buddy Poppies must be purchased through the Department of New York Headquarters.

Memorial Day is rapidly approaching. If planning to distribute Buddy Poppies, remember the actual shipping time is six weeks, with the cost at \$130.00 for 1,000 Buddy Poppies. Applications for Buddy Poppies may be attained through the Department of New York Headquarters.

With your help, we will be able to reach our 700,000 goal by Department of New York Convention. Let us work together to reach our goal.

U.S. troops (two tins based on a WWII theme and one on Vietnam). The VFW name is prominently displayed on the fronts of the tins. Plans call for the introduction of new tin images each year to ensure that customers keep coming back for more. I am excited to announce that Unibic would like to sponsor an ANZAC cookie sale contest that will last from May 15-July 15, 2010.

For an initial investment of \$144 (includes shipping), a VFW Post will receive 18 assorted tins, plus a free cardboard display stand. Posts could then sell the tins at whatever price is desired (\$10, \$15 or even \$20) and keep the profit. Additional tins can be conveniently reordered by the dozen, and you can reorder as often as needed. Sales tracking sheets will be included in each order mailed. VFW Posts then return these to Unibic by August 1, 2010 with the top national individual seller receiving \$500, the winning VFW Post gets \$1,000 and the VFW Department with the most sales will receive \$5,000.

Winners will be announced at the 2010 VFW National Convention in Indianapolis. ### Ron Sakonyi National Military Service **Programs Report**

Total NMS donations were \$1,926,806.14 for this fiscal year. VFW Posts donated \$388,476.52, Auxiliaries donated \$274,608.53 and other individuals and institutions donated \$1,263,721.09. February and March NMS donations from Department of NY were \$4,099 and \$6,671, respectively. This fiscal year Department of NY has donated \$34,519.35 toward NMS programs. At our annual spring conference, \$215 was raised in a raffle for NMS programs. **Operation Uplink** 

NMS provided 2,355 telephone cards over February and March to veterans and active duty personnel. During the Valentine's Day Free Call Day event, New York military service personnel made 2,969 calls home. On the 14 March Free Call Day event, New York military personnel made 2,607 calls home. The free call dates scheduled thus far for 2010 are: May 9th, May 30th, June 20th, July 4th and August 22nd. Please communicate these dates to any of our service members who you have contact with. **Unmet Needs** 

During the months of February and March, the Unmet Needs Program assisted 112 families with financial aid amounting to \$153,285 nationwide. During the same period, 170,407 military members and their families were supported through National Military Service Programs. Military Assistance Program (MAP)

Under the Military Assistance Programs, 30 events were conducted from February and March consisting of 36,964 attendees and involving 25 Departments at various times. No activity was noted for the Department of NY during this period. The new MAP Grant Application FAQ's are now available to download at www.vfwdepartmentresources.org. The FAQ's can be downloaded as a stand-alone document and it is also included in the MAP Grant application. This FAQ provides answers to many questions regarding the MAP Grant procedures.

#### **Memorial Commendations**

Nationwide, we had 68 casualties during these past two months. Twenty-five requests for the Memorial Commendation were forwarded. We had presented four of these Memorial Commendations.

They were: Cpt. Daniel Whitten from Iowa whose burial was at West Point; U.S. Army Specialist Alan N. Dikcis from Niagara Falls; U.S. Army PFC Jason Kropat from White Lake; and U.S. Marine Corps Sergeant Frank World from the Buffalo area.

My thanks to District 2 Commander Art Hanley, Commander David Dolson of Post 54, Sullivan County Council Commander Keith Rumsey and Dave Zarnecki for his coordination, Erie County Council Commander Lance Becker, and especially Ray Peterson, for efforts related to the presentation of the Memorial Commendation to the family of Sergeant Frank World.

It is wonderful that we provide more than \$3 million in scholarships and incentives each year. However, the real value of these programs is the contact we have with today's young people.

The values inherent in the service and sacrifice of America's veterans and their families must be encouraged in future generations. As wartime veterans and those who waited for them, you understand the values of teamwork, commitment, love of country, selflessness and sacrifice. These are the same values that made our nation great and have sustained her through her most difficult days. If this nation is to continue to survive, these values must be passed on. Our scholarship programs are one way this occurs.

I read, in essay after essay, how a young student meets a veteran and learns about how they feel about their service and their country. #### VA Updates Online Application for Health Benefits

Washington (May 5, 2010) - Veterans will find it easier and faster to apply for their health care benefits now that the Department of Veterans Affairs has updated its online Form 10-10EZ, "Application for Health Benefits."

"VA is committed to tapping into the best that technology has to offer to ensure Veterans receive the benefits they have earned," said Secretary of Veterans Affairs Eric K. Shinseki. "We continue to look for new ways to improve access to care and benefits."

This revised online application provides enhanced navigation features that make it easier and faster for Veterans to apply for their health care benefits. This new version also allows Veterans to save a copy of the completed form for their personal records.

The most significant enhancement allows Veterans to save their application to their local desktop and return to the application at any time without having to start over. Previously, Veterans had to complete the form in a single session.

This updated online form, along with the revised VA Form 10-10EZ, reduces the collection of information from Veterans by eliminating some questions.

In addition, there are minor changes to simplify the wording of questions and provide clarity in the instructions. Further enhancements to the online application are expected to be delivered in increments throughout 2010.

### **Letters to the Editor**

#### Dear Editor:

The Department of Veterans Affairs (VA) is launching a comprehensive study of women veterans who served in the military during the Vietnam War to explore the effects of their military service upon their mental and physical health. VA realizes that women veterans require specialized programs, and this study will help VA provide highquality care for women veterans of the Vietnam era.

The study, which begins in November and lasts more than four years, will contact approximately 10,000 women in a mailed survey, telephone interview and a review of their medical records.

As women Vietnam Veterans approach their mid-60s, it is important to understand the impact of wartime deployment on health and mental outcomes nearly 40 years later. The study will asses the prevalence of Post-Traumatic Stress Disorder (PTSD) and other mental and physical health conditions for women Vietnam veterans, and explore the relationship between PTSD and other conditions.

VA will study women Vietnam veterans who may have had direct exposure to traumatic events, and for the first time, study those who served in facilities near Vietnam and in the United States. These women may have had similar, but less direct exposures. Both women veterans who receive their health care from VA and those who receive health care from other providers, will be contacted to determine the prevalence of a variety of health conditions.

About 250,000 women veterans served in the military during the Vietnam War and about 7,000 were in or near Vietnam. Those who were in Vietnam, those who served elsewhere in Southeast Asia and those who served in the United States are potential study participants.

The study represents to date, the most comprehensive examination of women veterans, and will be used to shape future research on women veterans in future wars. Such an understanding will lay the groundwork for planning and providing appropriate services for women veterans, as well as for the aging veteran population today.
