Jack graduated from North Miami High School prior to entering the U.S. Army in July 1964. He completed his basic training at Fort Jackson, South Carolina. In 1966, he received his orders to report to Vietnam where he served as a Helicopter Crew Chief. After his tour of duty, he returned home in 1968. Upon his return, he joined the VFW Post in Miami. After serving many various positions in the VFW, he was elected as Post Commander in 1974 and served as the Dade County Council Commander from 1974 to 1976. In 1980 he then transferred to the Rome Post 2246. He was elected to the office of Quartermaster and served in that capacity until 2001. Currently, he is a member of the Rome Color Guard.

Jack has held many of the elected and appointed chairs in the 4th District and achieved All-American District Commander status in 2003.

He has two lovely daughters and a son who served with the Seabees in Kuwaiti and Afghanistan. His beautiful wife, Terri, supports all of his efforts. Jack's family was at Convention to celebrate his great achievement.

As Jack stated in his address to the delegates of the 91st Convention, his goals are to move the Department forward by strengthening its membership, programs and furthering the use of technology. Jack's motto is "Let's Get 'er Done." We wish Jack much success as our State Commander.

Comrades, the 2010-2011 year has begun and now is the time to start making appointments with your County and District Inspectors to get your Post inspected.

The most important thing to know this year is all Posts must file a 990 form in its entirety, no matter how big or small

your Post is. If the 990 form is not completed and filed, the IRS can pull your tax-exempt status.

Important for the Post to know is Quartermasters must be bonded in the proper amount, which should be enough to include all banking funds and investments.

A Post inspection is one of the requirements to qualify for a white hat.

Dr. Julian Takes New Position

Dear NYS VFW Members and Auxiliary Members,

Thank you for this opportunity to let you know about my work in an exciting new program at the VA. I have accepted the Health Behavior Coordinator position at the Buffalo VA. My decision to leave the Program Manager position at the Batavia VA, Jack Wisby, Jr. PTSD Treatment Center, was made after serious and heartfelt thought. I have been deeply moved by the 10 years of service in our Batavia PTSD Program. It has been a remarkable experience to be part of the growth of the clinic and to have the privilege of working with such a dedicated team, special Veterans, their families and Veterans' Service Organizations. Partnering with the NYS VFW and Auxiliaries has been especially rewarding, and your generosity and efforts continue to support Veterans in their recovery from trauma. I have every confidence that we will continue to hear wonderful and moving stories about Veterans healing at the PTSD Program in Batavia. The PTSD Team and the community support are strong and dedicated to providing excellent care.

I decided to accept the Health Behavior Coordinator (HBC) Psychologist position because of my passion to help Veterans develop healthy behaviors, prevent chronic illness and manage medical conditions. Over the years, I have seen so many of our Veterans struggle with illnesses that might have been prevented if they had taken better care of themselves, and so many Veterans suffering with conditions that could be more effectively managed with self-care education and practice. In my Batavia office, I had a sign with a quote from Mickey Mantle that reads: "If I knew I was going to live this long, I'd have taken better care of myself." Veterans deserve healthcare that offers them the information and support to take better care of themselves, and live as good a quality of life as they can and wish to have. In my new role, I have the great honor of assisting Veterans in doing just that!

One of my major responsibilities is to help Veterans, their families and Primary Care teams better understand how mental health issues, including PTSD, might interfere with healthy lifestyles and increase risk for certain illnesses. The HBC position is part of the new national Patient-Centered Medical Home (PCMH) program that is being established at each and every VA in our country. PCMH is a reorganization of Primary Care clinics that is based on the premise that the WHOLE person, not just the Veteran's medical condition, is crucial in determining healthcare plans, and that there must be partnership between Veterans and their families and healthcare professionals in efforts to promote healthy behaviors. As the Health Behavior Coordinator in PCMH, I will be able to assist Veterans, families and Primary Care providers in helping Veterans make changes that they would like to make for their overall health and well-being. This includes helping Veterans and their Primary Care Team promote general health and to address health risk behaviors as part of disease prevention and chronic disease management. For example, I will be helping Veterans with weight loss and maintenance, tobacco use cessation, and mastering selfcare techniques, such as increasing participation in regular exercise, healthy eating, sleep hygiene, stress management skills and relaxation techniques.

I feel privileged to be in a position that allows me to partner with many more Veterans and their families in the pursuit of Veterans' overall health and well being.

Thank you to the NYS VFW Leadership for this opportunity to share with you the news of this exciting new VA Program, and my role in the mission. I look forward to opportunities to partner with you in my new role.

The recent OTI held at SUNY Binghamton was very productive and informative. The VFW and Auxiliary once again presented an informative program to their respective members. A special presentation from the New York State Racing and Wagering Division was made. The presentation was on Charitable Gaming in New York State. They reviewed some of the pitfalls encountered by the VFW and Auxiliary.

This year's students enjoyed the programs and had a great opportunity to discuss their various issues with the staff and each other.

Digital Directory for District 3

The District 3 C of A was off to a great start at Stuyvesant Falls Post 9593. District Commander Wally Zincio outlined his agenda and described his 'Commander's Project'. In addition he displayed the membership award, a one of a kind Cooperstown Baseball Bat for the County Council attaining the highest number of new members for the year.

Commander Zincio announced that for the first time the District Directory would be a digital record on CD. The Commander outlined the financial considerations for his decision stating that saving money for veterans and community services was crucial, especially in today's economy. Distributing the Directory on CD, along with an abundance of other essential Post manuals, forms and other operational tools, was far more efficient and effective than dozens of printed booklets with limited use and information. The Commander explained that Past District Commander Don Mackey assembled the data and created the CDs for distribution for about \$50, saving *over four times that sum* by not printing and mailing the usual directory.

The news did not pass without some concerns. One member explained that many older members didn't have PCs and wouldn't get news and meeting information. Another member asked how we were supposed to be informed if we don't have a PC and if they were expected to go out and buy one.

Commander Zincio responded that National had started down the digital road a year or so ago and intensified the effort just this year by announcing the VFW Bylaws would no longer be mailed, but be made available online through the Internet. "National isn't done, that is just the first step, and we are in for much more technology down the road." He also reiterated the cost effectiveness and reminded everyone that most members showed up today because of computer technology.

The Commander went on to state that "...we cannot afford to keep doing business the same old way, technology is here and we have to grow if we expect to attract new younger veterans." He exclaimed that, "...e-mail is almost instant, snail mail takes days and if we don't take advantage of the new tools of technology we will be left behind. Our concerns for older veterans are justified, but if we don't attract and keep younger men and women who will take care of the older ones, there won't be anyone left."

The Commander continued to explain that these growing pains are temporary but will pay off in the end. "The young veterans of today grew up with computers - it's a way of life to them. We must adapt, we must learn, we must move forward and not get stuck in yesterday. We cannot afford the alternative. I've made the decision and it stands."

After the meeting, everyone enjoyed a hearty lunch and vigorous conversation about the new direction we seem to be headed. Overhearing many positive statements makes one wonder if the fears are real or perceived as many were more excited than worried, plus most were ready to get started. Plans could be heard for sharing CDs and printing necessary documents for those in need and deciding how best to get the word out. All in all, it appears the future has arrived for District 3.

A Victory for Women Veterens

New Veterans of Foreign Wars Post is well-deserved tribute and recognition

August 10, 2010 – For the most part, women veterans who served overseas or in a war zone have been given short shrift by the military and public. Some reportedly even have felt discouraged from seeking services to which they are entitled.

So it is pleasing to see that the new Dorothy Kubik/Katherine Galloway Post 12097, Veterans of Foreign Wars, has officially opened within West Seneca Post 8113. There are the requisite 41 eligible veterans to constitute a new Post; seven of them are men, some of them military spouses of the women building up the Post.

The point worth celebrating here is the recognition of the service and the sacrifices of women from this region who carried this nation's colors to such places as World War II, Korea, Vietnam, Iraq and Afghanistan.

In the current war in Afghanistan and the one in Iraq, women have been on the front lines, elbow-to-elbow with men. It can be seen as a nod to political correctness that women serving overseas or in a war zone aren't necessarily visualized in the same manner, or in as rough situations as their male counterparts. But any parent with a daughter serving in Afghanistan understands full well that she is not in a safe area.

Current wars have few set battlefields. American troops face insurgents, guerrilla warfare and door-to-door searches and fighting. A woman's job may be driving a supply truck in support of military efforts, but with roadside improvised explosive devices, that task can be just as dangerous - as attacks on convoys in the early days of the Iraq war proved.

Yet women were underrepresented at veterans' Posts and were missing out on mutual support and help with services and health benefits such as mammograms, gynecological and other basic care needs and prescriptions.

Marlene Roll, an adviser to the new Post, wanted to bring the women together to give them a shared-experiences social outlet and a place to talk. She discovered an overall desire to celebrate women veterans, especially considering that the word "veteran" often is viewed as an accolade for men.

VFW Post 12097 has been in the forefront of changing the approach to women veterans. It's a credit to that organization that its members have chosen to welcome home female veterans with a new Post designed to serve them.

James Gabriel Jr., a Hawaiian memorialized in the song "The Ballad of the Green Berets," was executed in 1962 by Viet Cong sympathizers while on a training mission seven miles from Da Nang, South Vietnam.

Billie Gabriel, one of James Gabriel's eight siblings, said, "The family is truly humbled by this honor to our brother. This will indeed be a bittersweet moment as I represent my parents at the ceremony. They would be ever so proud to see this day."

Gabriel added that because her brother was "the first native Hawaiian casualty of the Vietnam conflict, this event holds even greater significance for the state of Hawaii and every kanaka maoli. This field holds special meaning to every 5th Special Forces Group soldier at Fort Campbell, and to have my brother's name forever memorialized with such a sacred place for other families of fallen warriors is even more humbling."

Gabriel said her mother, Juliette, who has died, kept all of her brother's letters that he wrote from 1959 to '62. Rereading them recently, Gabriel was moved to tears. "I felt the youth in his words when he would tell my mom that he missed the coconut cookies that she made for him when he was a little boy. Then in the next paragraph, I could feel his strength and pride of being a soldier fighting for freedom."

Gabriel will meet with 120 Hawaii-born soldiers stationed at Fort Campbell and present them with a koa fishhook pendant, a gift from the Kamehameha School's class of 1969 and others. Also, the Royal Order of

A Hero Leads the Field

James Gabriel, Jr. (March 22, 1938-April 08, 1962), has been part of the lexicon of the Green Berets, the Army's Special Forces best known for their clandestine operations from the jungles of Vietnam in the 1960s to the mountains of Afghanistan today.

However, it has taken 48 years and the tireless effort of a Green Beret soldier to garner official recognition for Gabriel, a Hawaiian memorialized in the song "The Ballad of the Green Berets." He was the first Special Forces soldier and the first Hawaiian to be killed in the Vietnam War. On May 22, 2010, the 5th Special Forces Group officially dedicated Gabriel Memorial Field at Fort Campbell, Kentucky, honoring the 1956 Farrington High School graduate.

Kamehameha and retired Navy Capt. Gerald Coffee, a MidWeek columnist who was a prisoner of war in North Vietnam from 1966 to 1973, will donate leis that Gabriel will place on the memorial stones at the parade field. A maroon-and-white lei, a gift from his high school alma mater, will adorn his memorial stone.

Staff Sgt. Barry Sadler, a Special Forces medic in the Vietnam War, penned the lyrics that refer to Gabriel's wife, "back at home, a young wife waits" and their son, James Gabriel III, who was born five months after his death.

Billie Gabriel noted that Sadler, in his book, "I'm a Lucky One," said her brother's death was the inspiration for the 1966 hit song.

The Gabriel demonstration area and the Special Forces demonstration teams were established at Fort Bragg, N.C., in 1962. The area was featured at the beginning of the 1968 movie "The Green Berets," starring John Wayne.

However, Chief Warrant Officer 5 Bruce Watts, a second-generation Green Beret, said it has since been overgrown with weeds and abandoned.

The Fort Campbell parade ground has served for 22 years as a memorial site for 47 Special Forces soldiers and one Navy SEAL and was unofficially known as Gabriel Field. However, it and rows of sugar maple trees were to be demolished along with many of the post's World War II and Korean War barracks and buildings.

"They were just planning to bulldoze it," Watts, who has been a Green Beret 22 of his 27 years in the Army, told the Star-Bulletin. Watts said that soldiers have since 1988 planted sugar maple trees near stone monuments that were erected to honor fallen Special Forces soldiers.

"Since 9/11," Watts added, "there have been annual formations held on the parade ground dedicated to the memories of all our fallen." About two years ago Watts started writing letters and collecting information to bolster his campaign to keep the parade field and have it officially named after Gabriel.

"It just fell into my lap," Watts said. "He (Gabriel) was very heroic and inspirational in his last actions. It was a travesty to allow it to evaporate," he said of Gabriel's story. Gabriel, 24, a Specialist 5, and Sgt. Wayne Marchand were executed by Viet Cong sympathizers on April 8, 1962, during a training mission in a remote village seven miles from Da Nang. A 1962 Time magazine report said Gabriel and Marchand were in the third night of a two-week field exercise near the village of An Chau, 360 miles north of Saigon, when they were killed. His group was attacked at daybreak. Gabriel was shot three times in the chest and stomach while calling vainly for reinforcements.

Before he fell, Gabriel radioed a final message to the base at Da Nang: "Ammunition is running short and we are being overrun." He was captured and later killed.

VA Eases Claims Process for PTSD Treatment

For many U.S. troops now serving in Iraq and Afghanistan, coming home from war with Post-Traumatic Stress Disorder is hard enough. Once home, it can then take weeks, months, even years to qualify for federal disability benefits and receive treatment.

The Department of Veterans Affairs announced a new rule on Monday that aims to change that by making it easier for veterans suffering from PTSD to get the support they need. Veterans will no longer have to prove that a certain attack, bomb explosion or event in a combat zone triggered Post-Traumatic Stress.

It's a change that most agree has been a long time coming. "The new regulation will potentially benefit all veterans, regardless of their period of service, and it is not limited to veterans with direct combat experience," VA Undersecretary for Benefits Michael Walcoff said Monday during a news conference.

A 'Monumental' Change

Tom Tarantino, of the Iraq and Afghanistan Veterans of America and himself a veteran of the war in Iraq, says the decision is "absolutely monumental." He says the new regulation reflects the new realities of modern warfare where the lines between combat duty and noncombat duty are often blurred.

"You have a lot of people – you have truck drivers who drive the streets of Baghdad every day, and they get hit with IEDs," Tarantino says. "You have women who, you know, there's still the myth that women don't serve in combat. Well, if I'm a female soldier and I went on a hundred combat patrols as a medic or as an intelligence analyst, I shouldn't have to fight the VA to prove that I was in combat."

The new rule is designed to prevent what happened to veterans like Richard Sanchez. He served almost a decade in the U.S. Navy with tours in Afghanistan and Kuwait. In 2006, he was diagnosed with PTSD. But when he went to file his claim with the VA, he was denied benefits because he didn't have the right documentation.

All the while his condition was getting worse.

"I got very discouraged, and I locked myself in my room for about six months, and I didn't go out or speak to anybody. I sort of estranged myself from friends and family," Sanchez says.

After years of fighting – both his disorder and the VA – Sanchez's claim was finally approved. Along with the benefits, he says, came a letter of apology from the government.

"And they apologized for it in the letter, and they told me they were working on it and that it was a No. 1 priority for them," he says.

Looming Concerns

Sanchez says he's pleased with the changes the VA is making to care for vets with PTSD. But despite the praise coming from veterans groups, there are some concerns about the new benefits rule.

Fraud is one. Will making it easier to get PTSD benefits mean it will be easier for people to work the system? VA officials say that's unlikely since veterans looking for benefits still have to be diagnosed by a VA doctor. And if they are showing progress, benefits can be reduced.

Cost is another concern. The VA won't say how much the new rule will cost, but officials do expect new claims from people who up until now have felt deterred by the process. Walcoff says he and others inside the agency are trying to fix what he describes as the VA's image problem.

"I think a lot of veterans perceive us as more adversaries than advocates, so I think that there's a real culture change that is taking place with our employees. But maybe we didn't do everything we could do to be advocates for veterans," Walcoff says. "And I think that what this does is just another step in our attempts to become advocates, to say to a veteran: 'Look, when you apply for benefits, we're going to do everything we can to try to help.'"

Because the new PTSD rule is retroactive, that could mean treatment and financial support for hundreds of thousands of veterans who have been shut out for decades.

Texas Attorney General Investigates Fallen Heroes Foundation

Organizer Resigns; News 8 Investigates

KENNEDALE – Just two days after a *News 8* investigation was broadcast, the organizer of the United States Fallen Heroes Foundation has resigned.

The foundation has no idea how much money may be missing, but it still hopes to build a monument in Kennedale to servicemen and women who have died in combat since 9/11.

Walter Coleman said the United States Fallen Heroes Foundation was a nonprofit agency – but it wasn't.

Coleman used two names, and he represented himself as a veteran when he is not.

"I think it's sick that someone would essentially try to fraudulently raise money in the name of men and women who have given their lives for their country," said State Rep. Chris Turner (D-Kennedale).

The Fallen Heroes Memorial would have been located in Turner's district. He said the organization will have to change to move forward.

"There would have to be utter transparency, and they would have to comply with the best practices of nonprofits," Turner said.

As of Wednesday night, Larry Summers is the foundation's new chairman. A former Marine, he pledges changes in the Fallen Heroes board and practices.

"The foundation will be restructured as it should have been day one," Summers said. "This is how it's going."

One of the first tasks will be to revamp the foundation's Web site, which is still asking for money sent to Walter Coleman's home. Talks must be held with sponsors, such as Schlotzsky's, which have collected money for the memorial.

Walter Coleman told some people he collected millions of dollars; he told others that just thousands came in.

The Texas Attorney General is investigating. "I hope the Attorney General is able to determine how

much money was raised from how many people, and maybe we can get a true account of what has taken place," Turner said.

The Fallen Heroes Foundation has a contract for about 15 acres of land to construct the monument. City Manager Bob Hart will put the matter before the Kennedale City Council next month, so they can decide whether to continue the contract or possibly revoke it.

The City of Kennedale already has a modest monument to its own fallen heroes. It's now up to the attorney general, the new organizers and the City Council whether the Fallen Heroes Foundation will fly again.

Editor's Note: Several e-mails and letters have been received concerning this article and there are more than a few Internet postings about this developing issue. It seemed logical to put our members on alert to a possible scam and would encourage everyone to be very cautious when making donation decisions, especially to the organization mentioned here until we are advised otherwise. Updates will be posted as this issue progresses.
