New York VFW Partners with Excelsior College

VA Urges Veterans to Sign Up

for Electronic Payment of Their Benefits

VFW members and spouses are eligible for reduced tuition under new education partnership.



ALBANY, N.Y. March 18, 2011 – The Department of New York Veterans of Foreign Wars has signed an education partnership agreement with Excelsior College, a nonprofit distance-learning institution based in Albany, in a statewide effort to draw younger veterans and their spouses to the membership rolls of local VFW Posts.

The New York initiative, which provides reduced tuition for VFW members and their spouses, builds on VFW's national goal of boosting membership among younger veterans from the conflicts in Iraq and Afghanistan. All New York VFW members, regardless of when or where they served, are now eligible for the education partnership benefits, which were announced March 18 in Albany at the start of the New York VFW's Spring Convention.

to bridge the gap with veterans of the wars in Iraq and Afghanistan, the men and women who are vital to the future of our organization," said Jack Veazy, Commander of the VFW Department of New York. "We have taken a major step forward toward this goal by reaching out to New York veterans through an education partnership with a reputable, militaryfriendly college, which serves students nationwide. This agreement makes higher education accessible to veterans and their spouses."

National Commander-in-Chief Richard Eubank joined state VFW leaders at the event to commend the statewide initiative.

Eubank said he is hopeful the New York VFW's education initiative can serve as a model for other states seeking to reach younger veterans. Younger vets, he said, are key to the VFW's future because "10 to 20 years from now, this will be their organization."

Excelsior College President John F. Ebersole said, "We applaud the New York VFW for recognizing the role that high-quality education plays in the security and future of veterans and their families. We truly believe that this initiative will strengthen the VFW, contribute to veterans' quality of life, and provide a model for future such partnerships. For Excelsior College, which has strong, longstanding educational connections with all branches of the military and veterans, this is an extremely exciting partnership."

New Web Site for State

CIT Director Don Mackey unveiled the new State Web site at this year's Spring Conference in March. The new Web site was scheduled to go live on May 1st, but it is online now.

Shortly after his appointment as Director of the newly-created Communication, Information and Technology Department, Don submitted a five year plan to Commander Veazy, outlining technology goals for the Department of New York VFW. At the top of the list was the rebuilding of the old Web site using state-of-the-art software, new technology and today's technical culture and know-how.

After months of planning, designing and basic reconstruction, the new site took shape. As Don stated in his introduction, his entire staff has spent 8 and 10 hour days for over three months, creating a new window to our New York VFW. The "entire staff" Don referred to is just Don, a staff of one.

The new Web site demonstrates drop-down menus, news bulletin slide shows, flash pictures and many other eye-catching and appealing features. A far cry from the cluttered and sluggish worn out old Web site, the new Web site is expected to be a direct result of member needs, desires, input and expectations.

As Don said, "This is our first step into tomorrow and our first effort to draw and encourage younger members to join our innovative, creative and forward thinking veteran's organization. We are the greatest organization in the world, now the Department of New York members are demonstrating that and everyone can see it."

At the close of his presentation, Don issued a challenge asking everyone join him in the ongoing construction, helping him with ideas, suggestions and expertise so our new Web site can be the best it can be. As stated, the Web site was scheduled to go live on May 1, 2011 but with some extra effort, help from Comrades and just plain hard work, the Web site is online right now. Don reports that the response so far is quite favorable, and he is now able to rest for a few days before the next project kicks in.

There's still a lot to do before the May 1st deadline, but Don is confident everyone will be pleased and proud of our newest and biggest step into the 21st century.

Display and Observance of the POW/MIA Flag

The **POW/MIA flag** is an American flag designed as a symbol of citizen concern about United States military personnel taken as prisoners of war (POWs) or listed as missing in action (MIA). The POW/MIA flag was created by the National League of Families and officially recognized by the Congress in conjunction with the Vietnam War POW/MIA issue, "as the symbol of our Nation's concern and commitment to resolving as fully as possible the fates of Americans still prisoner, missing and unaccounted for in Southeast Asia, thus ending the uncertainty for their families and the Nation."

The original design for this flag was created by William Graham Wilkin III. National League of Families President and POW wife Evelyn Grubb also played a major role in conceptualizing the flag and gaining its widespread acceptance and use by the United States government and also local governments and civilian organizations across the United States.

The flag has been altered many times; the colors have been switched from black with white - to red, white and blue - to white with black; the POW/MIA has at times been revised to MIA/POW.

On March 9, 1989, a league flag that had flown over the White House on the 1988 National POW/ MIA Recognition Day was installed in the U.S. Capitol rotunda as a result of legislation passed by the 100th Congress. The league's POW-MIA flag is the only flag ever displayed in the rotunda, and the only one other than the flag of the United States to have flown over the White House. The leadership of both Houses of Congress hosted the installation ceremony in a demonstration of bipartisan congressional support.

On August 10, 1990, the 101st Congress passed U.S. Public Law 101-355, recognizing the National League of Families POW/MIA Flag and designating it "as a symbol of our Nation's concern and commitment to resolving as fully as possible the fates of Americans still prisoner, missing and unaccounted for in Southeast Asia, thus ending the uncertainty for their families and the Nation." Beyond Southeast Asia, it has been a symbol for POW/ MIAs from all U.S. wars.

The POW/MIA Flag will be flown on the grounds or the public lobbies of major military installations as designated by the U.S. Secretary of Defense, all Federal National Cemeteries, the Korean War Veterans Memorial, the Vietnam Veterans Memorial, the White House, the United States Post Offices and at official offices of the Secretaries of State, Defense and Veterans Affairs, and Director of the Selective Service System. Civilians are free to fly the POW/MIA Flag whenever they wish.

In the U.S. armed forces, the dining halls, mess halls and chow halls display a single table and chair in a corner draped with the POW-MIA flag as a symbol for the missing, thus reserving a chair in hopes of their return.

When displayed from a single flagpole, the POW/MIA flag should fly directly below, and be no larger than, the United States flag. If on separate poles, the U.S. flag should always be placed to the right of other flags [*the viewer's left; the flag's own right*]. The POW/MIA flag is always second in prominence to the American flag. It, too, should be placed under, or to the left (observer's right) of the U.S. flag, and to the right (observer's left) of any other flags on display. On the six national observances for which Congress has ordered display of the POW/MIA flag, it is generally flown immediately below or adjacent

to the United States flag as second in order of precedence.

Congress designated the third Friday of September as National POW/MIA Recognition Day and ordered prominent display of the POW/MIA flag on this day and several other national observances, including Armed Forces Day, Memorial Day, Flag Day, Independence Day and Veterans Day.

The 1998 Defense Authorization Act (P.L. 105-85) mandates that on these national observances, the POW/ MIA flag is to be flown over the White House, the U.S. Capitol, the Korean and Vietnam Veterans War Memorials, the offices of the Secretaries of State, Defense and Veterans Affairs, offices of the Director of the Selective Service System, every major military installation (as directed by the Secretary of Defense), every post office and all Department of Veterans Affairs (VA) medical centers and national cemeteries. The act also directs VA medical centers to fly the POW/MIA flag on any day on which the flag of the United States is displayed.

And finally this tidbit:

I have three flags and one pole. What order should they be in?

In military use, no more than two flags may be on a single pole. There is no official guideline for civilian use. The order, generally, is as follows, seen top to bottom: 1. U.S. flag

- 2. POW/MIA
- 3. State flags (host state first, then others in the order of admission)
- 4. US territories (Washington, D.C., Puerto Rico, etc.) 5. Military (in order of establishment: Army, Marine
- Corps, Navy, Air Force, Coast Guard)6. Other

Veterans Support Organization (VSO)...Scam or Fraud?

"You may, or may not, be aware of this group and its practices and the level of fraud they perpetrate on our sympathetic and unsuspecting public." That is a statement from one of many articles, e-mails and letters received outlining concerns over the group called VSO.

Some basics outlined here were obtained through several months of research. Unfortunately no law enforcement officials would respond when asked about this group making verification difficult if not impossible.

- They are headquartered in Florida and are active in 17 states.
- They collected \$2.6 million in 2009, and expect to collect about \$11 million this year.
- They are facing a fine of \$50,000 in Tennessee for fraud.
 They are most active in Florida, Pennsylvania, New Web and Planta a
- York and Rhode Island.
 They were the subject of a very detailed report by *Fox News* in New York, which earned them a place on the Alan Diaz Wall of Shame (www.myfoxny.com).
- Their primary tactic is to get so called "homeless vets" to stand in front of shopping stores dressed in camouflage fatigues and ask for donations. These same men are then allowed to keep 30% of what they keep. Some have found that some of the guys are not even Vets, by their own admission.
- VSO had a storefront operation on Chester Pike in Prospect Park, Pennsylvania. I visited the site and talked to the guys there who identified themselves as VSO employees.
- Their Director of Treatment, Jack Bittleman, is a convicted felon, and has a record in four states, according to *Fox News*.
- Their leader, Richard Van Houtan, was unable to produce a DD 214 when asked for one.
- Van Houtan reported income of about \$240K last year.
 They publish information that states they have given
- They publish information that states they have given much money to the Veterans Administration and touts their "partnership with the VA."
- A look at their numbers will lead any reasonable person to conclude that a lot of money is going to administrative costs and salaries, according to the *Fox News* report.
- They are siphoning money from legitimate Veterans groups, they prey on a patriotic, yet unsuspecting public and they must be stopped.

Until this organization can be verified and substantiated it would be wise to confront the individuals with specific questions like, "Where does the money go?" and "How much does the supposed veteran keep?" Requesting to see the supposed veterans DD-214 is not out of the question, but it is doubtful one can be produced.

Note: The editor of this newsletter (*Overseas Veteran*) confronted one of these individuals dressed in camo outside a local Walmart just before Thanksgiving last year. I asked the solicitor, who definitely wasn't a local, what organization he represented and he stated, "The VA." I asked where his office was and he stated "in the city" after which I asked if he meant the VA Clinic or the VA Hospital on Central Avenue in Albany and he said the hospital. So unless they had transplanted the hospital from Holland Avenue, he obviously had no idea where any VA institution is.

I pressured him for more information about the money collected, how much he kept, how much went to Florida and who specifically he sent the money to in Albany. His eyes got real big when I mentioned Florida and he became very nervous. That raised another red flag for me and I entered the store to find the manager, an acquaintance of mine for a long time. The manager was not available, so I went back outside to inform the scammer I was going to call the police. He had vanished.

A couple of weeks later as I drove to the same Walmart and the same guy was set up pilfering the public again. As I walked towards him he tossed his table, boxes, chair and money into his van and sped off faster than Superman leaping over a tall building. I haven't seen him since, but there are Veterans' observance days coming up and I'm betting he, or others like him, will be back. I wonder if he'll have a tax-exempt number or form I could inspect.

The moral to this story is that we must be diligent and check these people out. Veterans' Ranks Dip in Congress

The ranks of military veterans in Congress have shrunk to the smallest number since World War II, with barely 20 percent of the just-seated 112th Congress having firsthand experience in uniform.

Out of the 535 members of the new Congress, just 25 in the Senate and 87 in the House have served in the activeduty or reserve forces.

Compare that to 1969, when 75 percent of those in Congress had served. Critics say the loss of the perspective brought by those who have military experience is damaging to policymaking, particularly when the nation is engaged in two complex wars.

Daniel J. Dwyer

November 15, 1921 - February 19, 2011 Port Jarvis, New York



Daniel J. Dwyer, 89, of Port Jarvis, died Saturday, February 19, 2011, surrounded by family members at Bon Secours Community Hospital. Born in the "Acre" in Port Jarvis on November 15, 1921, he was the son of Daniel J. and Katherine Collier Dwyer.

Mr. Dwyer was an author, newspaper editor, veterans advocate,

sportsman, artist and had a long interest in Community Civic and political affairs. He spent many years in the newspaper business and achieved major success during that career by interviewing three presidents of the United States – John F. Kennedy, Dwight D. Eisenhower and in the Oval Office at the White House – Lyndon B. Johnson. His article on Johnson and that interview was nominated for a Pulitzer Prize.

Mr. Dwyer served our country in the U.S. Army in the European campaign in World War II. As a member of Roosa-Fleming Post 161, he chaired and co-chaired the annual Memorial and Veteran's Day parades for over 50 years. He served the New York State VFW as editor of the Overseas Veteran publication and as Director of Public Relations. He worked for many years on entitlements for veterans testifying at Congressional hearings. He was a 50+ year member of Metaque Falls Sportsman's Club, and 50+ year member of the Port Jarvis Democratic Committee. As a member of the Mount Carmel Society, Mr. Dwyer was Chairman of the "Acre Reunion" celebration, a one-of-akind reunion of over 1,000 people with roots in that special part of the city. He was a lifelong student of history and as a part of the Port of Jarvis Centennial Year celebration in 2007, he wrote a new (and now the official) history of Port Jarvis, "Our Town". He was a devoted member of the Minisink Valley Historical Society. In later years, he worked at Port Jarvis Library and treasured the friendships he had with his coworkers. A family statement noted, "We are grateful for the many wonderful memories of Dad over his long and happy life which recognized his special writing talents and love for the city. May he rest in peace."

Mr. Dwyer is survived by his wife of 64 years, Anne (Reagen); one son, Daniel E. Dwyer and his wife, Gloria of Bardonia; three daughters: Sharon Tomkins and her husband, Thomas "Skip" of Port Jarvis; Barbara Dwyer-Anderson and her husband, Peter of Port Jarvis; and Maureen Dwyer-Hirten and her husband, Michael of Okemus, Michigan, as well as his grandchildren: Caleigh and Keaton Anderson; and Morgan, Ashley and Joshua Gangaware. Also survived by devoted friends, Linda Siwarski and Edward Hedin and several cousins. He was predeceased by his sister, Sister Barbara Dwyer, South Carolina.

"Ahh, the Poppy"

When we see these cute little Poppies appearing on jackets, bags, hats and even on the collar of a family pooch, we know it must be May or November. Our thoughts, for certain, go to our brave women and men who have voluntarily banned together to protect our country.

But we may question: Why the Poppy? Who makes these Poppies? When and where did the tradition come from? Who benefits from those donations?

Let's go back to 1922, just before Memorial Day, when the Veterans of Foreign Wars first distributed the

Poppy and it became the official memorial flower of the Veterans of Foreign Wars of the United States. This was inspired by Army Colonel John McCrae's poem, "In Flanders Fields", where he described blowing red fields among the battleground of those fallen. A year later during the VFW's 1923 encampment, disabled and needy veterans assembled the Poppies and were compensated for their work to help them financially. On May 20th, 1924 the VFW was granted all trademark rights to the name "Buddy Poppy."

After WWI, the Franco-American Children's League and children in France and Belgium's devastated areas benefited from the donations collected. Today, disabled and needy veterans in VA Hospital's still assemble VFW Poppies. The cost of the Poppies continues to provide financial assistance to various veterans' programs and services. Additionally, it partially supports the VFW

From this document it was found that Sergeant O'Boza was authorized to wear the WWII Victory Medal, the Good Conduct Medal, American Campaign Medal, European-African-Middle East Campaign Medal with one bronze service star, the WWII Honorable Service Lapel Button, and the Expert Badge with a Carbine Bar.

After the awards were presented to the 90-year-old soldier, Post Commander Ricky Butler presented him with a WWII Veteran Cap from Post 5444 as a token of thanks for his service to his country. Refreshments were served and friends were made.

Veterans Helping Veterans

My name is Morris Sapp, Jr. I am a Life Member of the VFW and a disabled veteran. I, as some other veterans, reside abroad. We disabled veterans need your help.

There is a proposed amendment for the Department of Veterans Affairs' (VA) Foreign Medical Program (FMP), 38 U.S.C. 1724, sitting at the Veterans Health Administration (VHA). According to the VA it is "stuck between the VHA and the Office of Management & Budget (OMB)." In the FMP's current form it only allows for medical treatment of adjudicated service-connected disabilities at medical facilities overseas. The term "Adjudicated" too, denies other service origin disabilities.

This amendment to the FMP is for Disabled Veterans who travel and reside abroad to use local overseas facilities for medical care for both service and nonservice-connected disabilities. I am asking you to please sign our petition to the Honorable Senator Daniel Akaka, Chairman of the Senate Veterans Affairs Committee, and the Honorable Congressman Jeff Miller, House Veterans Affair Committee, to create a bill that will take the Proposal to Amend 38 U.S.C 1724 out of the VHA and put it on the legislative agenda. The Veterans of Foreign Wars of the United States realizes the urgency of this matter and, being an organization that is forward looking and cares for fellow veterans, has established a resolution supporting the amendment. The American Legion and the Disabled American Veterans (DAV) have stated their support for such legislation, too. Background

Phillip A. Williams, a disabled veteran, received a correspondence, dated January 6, 2008, from the VA's Health Administration Center (HAC), under the auspices of its Director, Ms. Mary Beth Saldin, stating "A legislative proposal to amend 38 U.S.C. 1724 has beer drafted to provide all-inclusive medical services to FMF veterans who have been adjudicated by the VA as 100% disabled. This proposal will be submitted for inclusion consideration on the VA's 2009 Legislative Agenda."

The latter having not occurred during 2009, I wrote Secretary Eric Shinseki a couple of times, receiving no response from him or his office. I even wrote the VHA and OMB and received no response. Finally I received a response, dated 11/05/2009, from Mary Beth Saldin, the Director of HAC on the part of the Secretary, and was told, "At this time the legislative proposal to allow 100% P&T Veterans who reside and travel abroad health care coverage for both service-connected and non-serviceconnected condition has not advanced as part of the VA legislative agenda. Moreover the legislative process involves an extensive amount of coordination within the VHA and OMB to address the priorities and assesses the need of each proposal."

To date, late 2010, this issue has not been corrected. And, why the OMB? This amendment will not cost the government any additional funds or give us any additional benefits. We would only be using the funds, which are allocated for our treatment, in the VA's Annual Budget, and this would likely save the VA some money. We would use local overseas medical facilities that are cheaper. We disabled veterans need help. We need our medical coverage. We are talking medical here. Further Information

In early 2003, my good friend, Phil Williams, and I went to Honolulu for medical treatment at the VA Clinic and Tripler Medical Center, where our medical records are located. While sharing a hotel room for a week and not being able to find a more affordable accommodation for the period we needed for our medical treatment, we went to the VA and asked for assistance for housing while we were being treated. The VA-Honolulu had what they referred to as Hoptels (2) they used to house off-island and other veterans from areas on Oahu while

they were being treated. We were told to go stay in a "homeless shelter" for the duration of our treatment. Due to the housing situation after some time we were forced to return home before completing our treatments. At the same time, veterans all over rural America were being treated at local (non-VA) medical facilities near their homes on a "Fee Basis." Veterans from the Pacific Islands were being flown into Honolulu and housed in a four-star hotel, at the VA's expense, along with family members, while being treated. We do not in any way begrudge our fellow veterans for this. We just expected and want better assistance from the VA and have been fighting to improve this assistance since then.

Our spouses and dependents are covered under CHAMPVA and can use this as needed at local overseas medical facilities. We, the veterans, are not covered. We are covered for only our adjudicated service-connected disabilities by the VA's FMP, which we can use at certified local medical facilities overseas. These are the same facilities that the U.S. Government uses for its employees and military personnel. Any non-serviceconnected disabilities, injuries or illness we have are not covered. Please keep in mind also that due to our serviceconnected disabilities no private insurer both locally and international will sell us any medical/health insurance. So, not due to any fault of our own we are uninsurable in the private sector. We have no way of covering ourselves for a catastrophic illness or injury. Tragic

I hope never again to read such an article that appeared in the *Pattaya Daily News*, dated December 19, 2007, involving an American disabled veteran and the VA FMP. The headlines read, "GALLANT VIETNAM VETERAN ABANDONED TO HIS FATE BY CALLOUS U.S. AUTHORITIES." The VA, after a prolonged period, corrected their treatment of this veteran and covered his non-service-connected medical care under the FMP, but he should not have been denied in the first place. The Director of HAC, after reading this article, stated, "*I understand your frustration that 100% disabled veterans is not entitled to all-inclusive medical care through FMP*."

In my correspondence with legislators, three senators and six congressional representatives have stated they would support such legislation, while one senator and four congressional representatives state they would look favorable upon such legislation. Two of these legislators are on their respective veterans' committees.

For those who put forth the argument, "you choose to live there," it's just like you have the right to choose where you live, we have that right, too; and a veteran's rights should not be denied or curtailed on the basis of access to medical care that is a problem, due to his or her service-connected disabilities which prevent us from purchasing medical/health insurance in the private sector. Furthermore, the apparatus (FMP) is already in

Rep. Michael Grimm Introduces First Bill, Supports Veterans Helping Veterans Establishes program to treat PTSD and train service dogs for disabled veterans

WASHINGTON, D.C. – Today, Representative Michael G. Grimm (R-NY) introduced the *Veterans Dog Training Therapy Act (H.R. 198)*, his first piece of legislation as a newly-elected congressman. The bill establishes a program that allows veterans to address Post-Traumatic Stress Disorder (PTSD) through therapeutic dog training and handling. The trained service dogs are then given to physically-disabled veterans to help them with their daily activities.

"As a veteran and an American, I wanted my first bill in Congress to give back to those who have given so much to us," said Rep. Grimm. "This type of program that allows veterans to help veterans could have a tremendous impact in New York. That is why I'd like to see a program established at the Brooklyn VA Hospital, which currently provides care for many of the veterans in my District."

H.R. 198 establishes a pilot program in three to five VA medical centers over a five-year period, as well as at centers with a training area for educating veterans with mental health conditions in the art and science of

assistance dog training and handling. It also calls for an assessment of the benefits of addressing the symptoms of PTSD through a therapeutic medium of dog training, and it encourages the use of shelter dogs, when appropriate.

The program's combined approach creates an opportunity to save money by offering an alternative treatment to PTSD while at the same time benefitting physically disabled veterans in need of assistance. In addition, with veteran suicide rates so high and more servicemen and women developing PTSD, this bill meets a crucial need for additional treatment methods.

"The bill takes a private sector approach to implement a policy that is efficient and cost-effective," said Grimm. "If implemented properly, I believe this program will save money, while addressing the growing need to help returning veterans. Caring for veterans while reducing spending make this program a win-win for all."

Veterans Stealing From Veterans

For several years now, the Department of New York has had to deal with a lot of issues in Posts throughout the State involving misconduct, misappropriation of funds, malfeasance and outright theft. Recently, the culmination of a case that started several years ago resulted in the indictment of a Post officer for stealing thousands and thousands of dollars from several veterans' organizations, including one of our VFW Posts here in New York State.

The VFW officer managed to gain access and sole control over every aspect of Post operations, funds and property by doing all the jobs no one else wanted. When he was finally in charge of everything, answering to no one, because of his intimidation and bullying techniques, he kept everyone at bay making it easy to steal at will.

There is nothing new in this case as it happens all too often. Members take the eagerness and insistence of a sole member to take on more and more responsibilities in stride. With every task, some of these eager beavers take on, there's a feeling of relief because someone else will do those jobs they are tired of or just don't want the responsibility so...they are off the hook. Surrendering one responsibility after another to just one person became easy and eventually assumed to be the right thing to do.

If there were times that these sole proprietors or the Post bullies in control were questioned, a tirade would erupt and the impertinence would be silenced. Eventually, more and more members realized something was wrong but had no idea what to do, so in effect they had been naturalized. By the time someone did step to the plate and insisted on action, it was often too late and the damage was done. Thousands of dollars vanished, a Post ravaged and pillaged while members stood by and let it happen.

It could have been prevented if members took their responsibilities seriously, divided the responsibilities and did their jobs. More than anything else the members should have followed the Bylaws. Making new rules, or running things according to one person's dictations, is an invitation to those with no conscience to take whatever they want.

What troubles many is that Veterans are stealing from Veterans and they are doing it with absolutely no second thought or regret. We trust veterans, we trust our friends, we know them and we assume just being in the VFW means we are safe and need not be concerned. But that is deception, a lie we choose to believe and a path to destruction.

The State Director of Charitable Gaming Compliance at the New York State Racing and Wagering Board in Albany, New York, Daryll Messner, addressed the Department C of A on January 15, 2011 to convey some alarming statistics and warnings. He informed the officers that 90% of all the investigations for embezzlement, theft and misappropriation of funds in 2010 involved VFW Posts and six of the Posts were repeat offenders. One inspector alone has 32 active cases where Bell-Jar funds are missing, and 17 of those involve VFW Posts. Another inspector stated Post members are not watching and monitoring the few in charge – they aren't holding anyone accountable. He explained the importance of including copies of Post minutes approving the spending of Bell-Jar monies for specific reasons and reporting every penny earned and spent.

Director Messner held up a calendar for December of 2010 and showed that more than 75% of his month was consumed by VFW issues and in every single case, only one person was in total control of multiple Post accounts and funds, as well as the Bell-Jar funds, records, reporting and games. In nearly every case, monies were manipulated from one account to another, much like a shell game, making the job look so very complicated that no one understood what was being done. Over time that one person managed to buy a new truck, take a trip to Turning Stone and pay for a pool, but the Post bills were not being paid. In every case had members demanded an accounting, audits and proper reports, demanded transparency and enforcement of the rules and regulations, the complaints and investigations would not be necessary.

These cases, such as the most recent former VFW Commander accused of embezzling well over \$200,000 from several veterans organizations are not uncommon. Seldom do the cases involve small amounts of money; they are stealing hundreds of thousands of dollars.

Director Messner stressed that these investigations can take a long time, and some cases take two to four years. Many go on stealing for years, feeling secure, because they don't take very much at any one time and feel no one will guess anything's missing. Over time greed motivates even more brazen acts and soon larger and larger amounts vanish. These thieves get comfortable as time passes and nothing seems to be happening; they feel they are safe and no one is wise to them. They do not realize they are on the radar, the investigation is grinding on, slowly to be sure, but as every number on the falsified reports are scrutinized, the closer they are to residing in the local jail or prison for a very long time.

Follow the Bylaws; don't create new rules to satisfy one aggressive member. Why do you think these thieves want the rules changed? It makes it easier to plunder and pillage, that's why. The Bylaws work and they know it, that's why they want them gone. Don't give away your Post and don't allow it to be stolen on your watch. That's right..."your watch"...you are responsible; every member is. We are a band of comrades serving brothers and sisters not observers watching from the sidelines while others loot our Post homes and then ask why. When it happens it's because we let it happen...while we watched.

BAGHDAD – Four noncommissioned officers from 1st "Vanguards" Battalion, 18th Infantry Regiment, 2nd Advise and Assist Brigade, 1st Infantry Division, United States Division – Center competed Feb. 15 at Camp Taji, Iraq, to be among the newest members named to the Sergeant Audie Murphy Club, which recognizes the best of the best among the NCO corps.

Named after one of the most famous NCOs in Army history, the SAMC was created in 1986 at Fort Hood, Texas, by Lt. Gen. Crosbie Saint and Command Sgt. Maj. George Horvath to honor Murphy's service to the nation and to create a group for the finest NCOs Fort Hood had to offer. By 1994, it had spread Army-wide.

Murphy served with great distinction with the 15th Infantry Regiment, 3rd Infantry Division during World War II and fought with his unit in North Africa, Sicily, Italy, France, and Germany. He was the recipient of 33 awards and decorations, including the Medal of Honor and is widely regarded as the most decorated NCO in the U.S. Army.

The battalion-level competition was developed and conducted by Command Sgt. Maj. Michael Evans, a native of Columbia, S.C., command sergeant major of 1st Bn., 18th Inf. Regt. Evans himself was inducted into the SAMC in 1999 as a sergeant first class.

"Being inducted into the Sergeant Audie Murphy Club is a significant accomplishment for any noncommissioned officer within the formation," Evans said. "It is a time (for inductees) to set themselves apart from their peers, accept the challenge and get after it."

The competition was designed to challenge the NCOs in physical fitness, technical and tactical proficiency, and leadership, military and Audie Murphy-related knowledge.

During the evaluation, the nominees were given a physical training test in which they had to score at least 90 points, on a 100-point scale, in each event. After completing this, they conducted an eight-mile foot march to a rifle qualification range where they conducted a "stress shoot," or a firing while tired and under pressure, to qualify with their assigned weapon.

For many candidates, the physical aspect of the board proved to be difficult but rewarding.

"The physical aspect was a fun challenge which pushed me to improve myself," said Staff Sgt. Joseph Speris, a squad leader with Company B, 1st Bn., 18th Inf. Regt.

Overall, Evans said he was pleased with the hard work of the participants and expects more NCOs to attend future boards.

"The Soldiers who attended the board today are the true champions," he said. "They accepted the challenge to rise to the top."
