Post-2001 Veterans Can Get \$25/\$500 for Taking a Survey

Calling all veterans of at least one deployment to Iraq or Afghanistan: If you are between the ages of 18 and 59 and can read and write English at an eighth-grade level or higher, researchers with the State University of New York-Albany and University of South Florida want to hear from you. They'll pay \$25 for the first 900 participants to take a survey, and you also get a chance to win a \$500 Amazon.com gift card.

The research study, according to USF officials is to understand the impact of combat deployment on a variety of behavioral health outcomes.

The Defense Department-funded study is part of ongoing research at the universities' Restore Lives Center - a collaboration that aims to improve mental health treatment for troops and veterans.

Other ongoing studies involve the effectiveness of specialized eye movement therapy on reducing Post-Traumatic Stress symptoms and a web-based therapy for mild traumatic brain injuries. Veterans can sign up for the current survey at **www. myserviceimpact.com**

Department Hospitality room at the National Convention. A few of us got together to understand what it would take to run from the floor for Jr. Vice.

As soon as I got home, I called a very good Marine friend of mine – PSC Ron Bush. I asked Ron about running for State Commander.

I did not get from him the response "you need to wait your turn" (which then was 41 years). Ron supported the idea and thought we could do it.

I then talked to two other good non-Marine friends: PSC Jim McNally and PSC Hal Burke. They also thought it was time for someone to step forward.

I have found in my work experience that if you surround yourself with people who think like you do, then you don't really need them. I will need different points of view and people who have experienced things that I have not in order for us to make good decisions. This is why I will continue to use the council of many different people within the department this coming year.

Membership – We lost more members this year in the Department and our numbers continue to fall. "WE NEED TO STOP THE BLEEDING THIS YEAR," a quote from DOC.

Michelangelo once said, "The greater danger for most of us is not that we aim too high and we miss it, but that we aim too low and we reach it." So let's not aim for 100% membership this year. All-State Awards: Requirements are going to follow Michelangelo's goal of Aiming High. Doing the bare minimum per the Bylaws does not make us All-State material. By taking the extra steps to be a shining star, make us All-State material. Read the requirements and get a good understanding of the points system for this year.

All-State/All-American requirements will be posted on the Department web page **VFWNY. com** shortly after Convention. They will not be mailed due to budget cuts this year.

Remember this: What we think or what we know or what we believe...in the end is of little consequence. The ONLY consequence is what we do and NO ONE DOES MORE FOR VETERANS than us. So let's AIM HIGH THIS YEAR

on "More Forms", and then click on "Inspection Reports for Posts, CC & District". Please take the time to review it so you know what the inspectors are going to be asking for.

Please note that question #10 pertains to the IRS 990 Form. Each and every Post must file a 990 with New York. It does not matter how much or how little income your Post takes in, but it is a state requirement for all nonprofits to maintain their nonprofit status. A copy of your 990 must be attached and sent in with your inspection report. If you insist that you "never had to do one before" and plan not to file one or think it is a private matter, you could be running the risk of an audit done by the State of New York IRS.

New York has gotten very tough in this area so if you are found to not be in compliance, you lose your nonprofit status and they will make you pay income tax on money taken into the Post going back to your last filing. If your Post owns property, you could be paying property taxes back to your last filing. FYI: 990s are public record and each Post is a part of the larger Department and National organization that allows Posts to obtain the nonprofit status.

If you have questions, you can talk to your District Commander or call me at 716-937-4549. Let's see if we can accomplish these inspections within the next few months and get it off our checklist for the year!

History of Commander Durkin's Bunny

On December 1, 1955, the squadron was re-designated as VMCJ-2 after former Marine Photographic Squadron 2 (VMJ-2) was decommissioned and joined VMC-2. As 1955 was also the year *Playboy* magazine was first published, it soon followed that the squadron adopted the *Playboy* name and logo with their permission.

Since its designation in 1975, VMAQ-2 deployed detachments of EA-6A aircraft [designated Detachments Alpha, Bravo, and Charlie] and EA-6B aircraft [designated Detachments Xray, Yankee, and Zulu] on a continuous basis in support of Marine forces in the Western Pacific and in support of Fleet Commanders on aircraft carriers, including lengthy deployments on the USS Midway, Nimitz, America, and Saratoga. In 1977, the squadron transitioned to the EA-6B Prowler and now operates the Improved Capability III version of the aircraft. In 1986, a detachment of the squadron participated in U.S. raids against Libya.



A Veteran Commits Suicide Every 80 Minutes...

...but the true number of veterans who die by suicide is unknown. The VA estimates that 18 veterans kill themselves every day, but this number is extrapolated from extremely limited data. Specifically, states provide death data to the Centers for Disease Control (CDC) for inclusion in the National Death Index, but only 16 of U.S. states indicate veteran status in their data. The number of veteran suicides from the remaining 34 states is extrapolated to estimate the overall number of veteran suicides. Further, the current numbers are extrapolated from three year-old data.

George Washington stated, "The willingness with which our young people are likely to serve in any war, no matter how justified, shall be directly proportional to how they perceive the Veterans of earlier wars were treated and appreciated by their nation." **Veterans and Suicide**

The Army Times stated in 2010 that an estimated 18 veterans die by suicide every day. The Times also stated that as many as 950 suicide attempts occur every month among veterans already receiving VA services. The rate of younger veterans 19 to 29 who are receiving VA services each month is lower than other age ranges.

Young veterans (under 25) living in rural areas and getting treatment from a clinic rather than an established mental health program were not likely to continue their PTSD treatment, especially in group therapy. At the same time the suicide rate for 18 to 29 year olds getting VA treatment is lower than the rate of those not getting treatment.

There's a stigma among males when dealing with equals or the public in general. Many older veterans imply that every veteran should "suck it up and move on" and degrade the younger veteran's experiences and negate their feelings and emotional struggles. "After all, the real veterans survived and manage just fine, and we won the war," they say.


There's new data that shows an average of 950 suicide attempts every month by veterans receiving treatment at some VA facility. Data shows that 7% of veteran suicide attempts are successful and those that don't succeed try again within months.

The statistics are alarming and there doesn't appear to be any concrete answers because the experts just don't know what's causing this alarming trend. There needs to be a concerted tracking effort if there is to be any hope for conquering this tragedy.

This problem is not confined to the VA or any other treatment center. Everyone has to be aware and determined to make a difference, our heroes deserve better and they deserve every possible chance to survive. Their loved ones deserve our support as well because the price paid by families left behind is catastrophic and the scars are forever.

In June of this year the Department of the Army stated there was a total of 154 suicides. This is higher than U.S. combat deaths in Afghanistan during the same period. This number is JUST among active duty army troops and does not reflect Marine, Air Force, Navy and Coast Guard or those serving in the reserves and National Guard or veterans who have already returned home.

This chart shows the ratio of suicides per military service from 2001 to 2010, leaving us to wonder what the rates are for the last two years.



Some statistics on those serving in the military: 95% males 95% are enlisted 80% are white 47% under age of 25 41% were receiving treatment 34% stated their intent to die 30% failed the first time 20% were on depression medication 14% had a history of self-injury

Everyone can help. If the symptoms are there they can be seen, heard and felt giving us the chance to intervene. Learn the signs, know the risk factors, and get them help.

Some Risk Factors are:

Previous Suicide Attempts Personal Failure Recent Loss Diagnosed Depression or Anxiety Family History of Suicide Low self-esteem **Some signs of suicidal tendencies are:** Depression Hopelessness Anger No Joy in life Isolation Insomnia or Excessive Sleeping

- Change in Eating Habits
- Giving Away Valued Items
- Preoccupation with Death
- Expressing Suicidal Thoughts (drawing, writings, songs)
- Substance Abuse
- Sudden Change in Behavior
- Calling old friends, particularly military friends, to say goodbye
- Visits to graveyards
- Obsessed with news coverage of the war Wearing their uniform or part of their uniform
- Talking about military honor
- Becoming overprotective of children
- Standing guard of the house
- Hording alcohol
- Spending sprees, buying gifts for family members "to remember me by"
- Defensive speech ("you wouldn't understand," etc.)
- Stops making eye contact or speaking with others

They might make statements that should get attention...

"It'll all be over soon" or "I hate my life." "I wish I were dead" and "You'll be better off without me" or "Nothing matters anymore."

members missing from your own Post. This would not be recruiting, but rather would be reconnecting with an old friend and Veteran. Find out why that Veteran left the Post and did not renew. Ask that Veteran to come back to your Post's social functions and begin a new era in the Veterans of Foreign Wars.

Another source of membership is our At-Large membership for the Department of New York. Who fits this membership? Veterans who's Post may have closed and they were not aware of it and members who have joined the VFW online. The third source of membership is our neighbors who have moved from another state and may still maintain their membership in a Post from another state or they have become a delinquent. Ask these Veterans to transfer into your Post or reinstate them.

Why do I suggest we attempt to renew and reinstate these members? The Department of New York only needed 1,901 members to renew or reinstate for 100% for the fiscal year just ending. Yet, we had 6,778 unpaid members in New York State late in May. At the same time, there were 5,289 delinquent at-large members and 2,834 delinquent members from out of New York Posts living in New York. We don't have to go very far to achieve our goals. Comrades:

On behalf of Department Commander Jim Durkin, I'm proud to report that 65% of last year's goals where reported to committee in both chambers of the State Legislature and 15% were signed into law.

Goal No. 1, S.6089 by Senator Ball and A9473 by Assemblyman Ortiz, will create a "Visor Communication Card" to assist law enforcement officers to identify the driver as a person with traumatic brain injury (TBI) and establish a New York State Traumatic Brain Injury Fund.

Status: Referred to Senate Transportation Committee on January 4, 2012 and referred to the Assembly Transportation Committee on March 5, 2012.

Legislative

Goal No. 2 would allow combat wounded civil servants with career ending injuries to receive their Civil Service pensions.

Status: Unknown

Goal No. 3, S.6904 by Senator Larkin and A.8067 by Assemblyman Paulin, will allow all New York State veterans who deployed in defense of our nation to buy back their military service. This bill would amend the retirement and social security law to allow combat veterans of the State and City of New York Retirement Systems to buy back their military service no matter when they served. We request that this law cover periods of military conflicts as determined by the awarding of an expeditionary medal. We also hoped to develop language that will make this amendment a reality and cover all pension systems and all conflicts.

Status: Referred to Senate Civil Service and Pensions Committee on April 9, 2012, amended on May 14, 2012 and referred to the Assembly Ways and Means Committee on May 1, 2012.

Goal No. 4, S.7489 by Senator Ball and A.10388 by Assemblyman Ramos, provides service-disabled veteran owned and vet-*LEGISLATIVE, continued on page 6*

I am honored to be named as Department Commander, James Durkin's Special Project Chairman. The Commander's Special Project for the coming year is the funding of Scholarships for the Voice of Democracy and Patriot's Pen Programs.

The Department of New York and the Ladies Auxiliary provided the funding for three scholarship prizes at the National level of these programs. For the Voice of Democracy, we present the Rev. Albert G. Salmom Memorial Award of \$3,500 and the Troy and Sandy Rothbart Memorial Award of \$2,500. The Patriot's Pen Award is the Clyde A. Lewis Award of \$4,000. Educational Benefits for Families

Spouses and dependents who receive veterans' survivor education benefits and later earn GI Bill benefits in their own right could have a combined 81 months of benefits under the new law that takes effect in 2013.

Eligible service members and veterans who have earned GI BILL benefits through their own service would still be limited to 48 total months under a provision of the Honoring America's Veterans and Caring for Camp Lejuene Families Act of 2012 that was signed into law August 6.

Full eligibility for two veterans' education programs is aimed mainly at the children of those who die on active duty, who could attend college using survivor benefits, then use Post-9/11 GI Bill benefits for further education. The new policy takes effect October 1, 2013.

eran owned small businesses with increased opportunities state contracting.

Status: Referred to Senate Veterans Committee on May 25, 2012 and referred to the Assembly Governmental Operations Committee on May 24, 2012.

Goal No. 5, S. 2724-A by Senator Addabbo and A. 4269-A by Assemblyman Miller, will acquire funding for our VFW Service Officers and allow the State's VSO Service Officers to increase the revenue they generate in the form of VA Compensation for New York's veterans. Last year, they generated \$57,180,718 in compensation, which was spent in New York's economy. Additionally, we worked with Department Senior Vice Commander Mike Pascal and the Senate Veterans Committee to secure another grant to fund this year's Service Officer operations.

Status: Referred to Senate Investigations and Government Operations Committee on January 9, 2012 and amended on January 31, 2012, and referred to the Assembly Ways and Means Committee on January 4, 2012 and amended on January 25, 2012.

Goal No. 6, S. 5381 by Senator Ball and A. 1386A Assemblyman Ortiz, will provide for a statewide cemetery in New York State under the federal VA State Cemetery Grant Program. This program assists states in providing gravesites in those areas where the National Cemetery Administration (NCA) cannot fully satisfy Veterans' burial needs.

Status: Signed into law on March 30, 2012 by Part W of Chapter 57 of the Laws of 2012.

2012 was a good year for veterans legislatively.

The Legislative Committee met on Friday August 3, 2012 to develop a strategy and select the following Legislative Goals for the 2013 Legislative Calendar:

Goal No. 1 Acquire Funding for VFW Service Officers amend S2724 and A4269 to include all state level Veterans Service Organizations that are Congressionally Chartered with VA recognized Service Officers and to ensure that the cost of altering tax forms to include this option be paid for with funds generated by the option prior to disbursing any funds.

Goal No. 2 TBI Bill S6089 and A9473 amend to provide training so that law enforcement officers can recognize veterans with TBI and PTSD and to provide the option of having a service connected disability status indicated on a veterans NYS Drivers Licenses or non Drivers Licenses Identification.

Goal No. 3 Veterans Enterprise Opportunity Act amend S7489 and A10388 to provide all veteran owned businesses and enterprises the same preference for bidding on state contracts as those offered to other minorities and protected classes.

Goal No. 4 Alternative Veterans Property Tax Exemption S4387-2011 to amend subdivision 1 of section 458-a of the real property tax law by adding a new paragraph, defining "active duty member of the military".

Goal No. 5 Civil Service Veterans' Buy Back Bill S6904 and A8067 will allow the newest veterans and veterans who received expeditionary medals to buy back service time on government pensions. Reintroduce S3954 to include all expeditionary service.

Goal No. 6 Veterans Courts Support the establishment of a Veterans' Court in each of New York State's 13 Judicial Districts.

As you know our work cannot end here. I challenge each of you to take the lead in your Districts, Councils, and Posts and organize our members to write and visit our legislators in their home office to convince them to make each of this year's public laws. Publicize our Legislative Goals by conducting interviews and press releases using Talking Points with your hometown newspapers. Finally, track the progress of our goals so you can provide the grassroots input needed to guide our Committee's efforts in securing a third reading and affirmative vote in both chambers for all of our goals.

Again comrades, thank you for the opportunity to serve this great Department.

Comrades,

I would like to thank the members of the Department for your support and the confidence you have placed in me by my reelection to the office of State Judge Advocate. I extend my best

wishes and congratulations to our State Commander James Durkin, State Sr. Vice Commander Michael Pascal, State Jr. Vice Commander, PNSG, William "Doc" Schmitz, State Quartermaster Robert Barnhart, State Surgeon Dennis Sullivan, State Chaplain Father Kane, all the newly elected and appointed Department, District, County Council and Post Officers.

Congratulations to PSC Harold "Mick" Leavor and the officers who served with him on an outstanding year.

Once again, we would like to remind you that each year the State Commander receives letters of concerns or complaints regarding issues within various Posts throughout the State. While we are sure all of the concerns or complaints are sincere and valid, there is a chain of command that must be followed before these letters reach Department Headquarters. The National Bylaws and Manual of Procedure Article IX provide instruction for those issues that result in disciplinary action. Post level concerns or complaints begin by presenting the problem at a Post meeting. If after presenting the issue to the Post membership no resolution can be reached, follow the steps outlined in Article IX. It is impossible to address the influx of letters received at Department Headquarters if the correct procedures are not followed. Following the steps outlined in Article IX should bring the issue to the appropriate level of the VFW for resolution.

PLEASE NOTE: A LETTER OF CON-CERN OR COMPLAINT SENT DIRECTLY TO NATIONAL HEADQUARTERS WILL NOT SPEED UP THE PROCESS. IT ACTU-ALLY SLOWS IT DOWN. NATIONAL FORWARDS ALL COMPLAINTS BACK TO THE DEPARTMENT FOR REVIEW AND APPROPRIATE ACTION THUS DELAYING THE PROCESS EVEN MORE. NATIONAL OBSERVES THE CHAIN OF COMMAND AND EXPECTS ALL VFW ENTITIES TO DO THE SAME.

The following amendments to the Department Bylaws were passed at this year's State Convention and will have an effect on the Districts, County Councils, Post and Membership. I am providing a recap of those Bylaws and their effect for your information and action as necessary.

Article XVIII, Sec. 1.00 The per capita tax (dues) of Men's Auxiliary Members of the Department shall be \$5.00 per annum by every member in good standing.

The per capita tax (dues) of Men's Auxiliary Members of the Department shall be increased by an equivalent amount whenever the Department or National VFW annual member per capita is raised for every member in good standing, except Life Members.

The Men's Auxiliary Units will receive notification from the State Adjutant after January 1 of the dues payable to the Department of New York for 2012-2013.

<u>Article VII, Sec. 4.00</u> Department Delegate registration fee. THIS IS NEW

Each Post will pay, in advance to the Department of NY, a Department Delegate registration fee of ten dollars (\$10) which shall entitle the Post to one identified registered delegate for the Department Convention. Each additional delegate attending the Department Convention will pay a five dollar (\$5) delegate fee.

This new Bylaw requires each Post in New York to register (at minimum) one Post Delegate to the Department Convention.

The National Bylaws, Article II Sec. 213 Arrearages, Deficiencies and Omissions, addresses this issue: Any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year or other obligations shall be deprived of all representation in County Council meetings (if applicable), District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

Posts will receive notification of delegate fees from the State Adjutant after January 1, the delegate registration fees payable to the Department of New York for 2012-2013.

Article XIII Miscellaneous

Sec. 4.00 It shall be permissible for the Convention Corporation to charge a fee, in their discretion, not to exceed seven dollars (\$7.00) for advance registration and ten dollars (\$10.00) for registration at the Convention Site, for the Convention badge, program and any other items that they may wish to include in the form of entertainment for the delegates and visitors.

This fee registers a delegate/member for the Convention only.

Please do not confuse this Convention fee with Article VII SECTION 4.00 Department Delegate Registration fee.

<u>Sec. 2.04-Regular and Special Meetings; Quorum; Authorized Attendees.</u> (was Article III Sec 3.05)

Each County Council shall hold an annual County Council Convention for the purpose of electing County Council officers and for the transaction of business; such Convention to be held not less than ten (10) days nor more than forty-five (45) days prior to the convening of the Department Convention.

This adjustment for the time period in which a County Convention can be held is consistent with the changes made to the date of the National Convention.

I pledge my support to the Officers and members of the Department of New York. Once again, thank you for allowing me the privilege of serving as the State Judge Advocate.

VFW Teachers' Awards

The VFW launched the National Citizenship Education Teacher Award in 1999 to recognize classroom teachers for promoting citizenship education. Three teachers from each level (grades K-5, 6-8 and 9-12) are selected as national winners. Each national award teacher winner receives the Past Commander-in-Chief John Smart Award and \$1,000.00. Their respective schools also receive a \$1,000.00 award. They receive a paid trip to a VFW National event to receive their award.

Visit http://www.vfw.org/Community/ Teacher-of-the-Year/ or the Department of New York website www.vfwny.com; then click on Dept NY, then Programs and Awards and Teachers Award for more information and entry forms. **Deadlines:**

November 1: Deadline for teacher nomi-

nations at the Post. Post judging should be completed by November 15th and winners sent to District. District judging should be completed by December 15th and winners forwarded to the Department. Department judging should be completed January 10th and winners submitted to VFW National Headquarters by January 15th.

SPECIAL NOTE: Anyone may nominate a teacher, except for the teacher himself or herself (or the teacher's relative.) While a school official may nominate a teacher, permission from a school or district is not required.

Judging:

Select competent and unbiased judges. A panel of at least three to five judges is recommended. The VFW chairman should be present at the judging to provide assistance, but should not be one of the judges. Prior

to the judging, the chairman should review all nomination forms to ensure they adhere to the rules. Make sure entry is not a selfnomination. The nominator should keep to the 350-word limit and sign the nomination.

Judges should grant points based on four criteria with the potential of 100 points as follows:

1-25 points: Does the teacher teach and/ or model good citizenship and community involvement?

1-25 points: An innovative approach to teaching citizenship.

1-25 points: Development of resources to teach citizenship education.

1-25 points: Passion for teaching citizenship education.

Community Service

How a Post interacts with its community determines the relevancy of the Veterans of Foreign Wars. Someone once said, "People don't care how much you know until they know how much you care."

The VFW and its Auxiliary's ability to impact veterans, youth, political issues, patriotism, civic pride, volunteerism, almost anything you can name, is directly dependent upon the Post being recognized as a caring and involved participant in the community.

The Post is, for most Americans, the only thing they know about the Veterans of Foreign Wars. Make sure those Americans in your community have a favorable opinion of our great organization and our veterans.

Importance of Reporting VFW & Ladies Auxiliary Volunteer Service

During the 2011-12 VFW & Ladies Auxiliary Programs' year over 8 million volunteer hours and over \$48 million were contributed towards the completion of community service projects by Posts and Ladies Auxiliaries.

It is essential that the VFW Department establish and maintain a system of program reporting to enable the VFW to substantiate its tax-exempt status and provide information about Post and Ladies Auxiliaries volunteer efforts in their communities.

Biannually, the VFW Department will provide the VFW National Community Service Program a report compiling each Post (to include Cooties, Sons of the VFW and Cooties Auxiliary) and Ladies Auxiliary (to include Junior Girls) community service projects that include the number of volunteer hours for the time period and the dollars donated to complete the projects. The dollars donated should include the 14 cents mileage amount for charitable work allowed by the IRS, value of donating the Post Hall use to community nonprofit groups and other in-kind donations.

For reporting purposes, only volunteer service projects benefiting the community are to be reported. Projects/activities benefiting VFW and Ladies Auxiliary members only cannot be reported.

The creation of a Post and Ladies Auxiliary community service record book to display at the Post Home or to display at community events is a great public relations tool, however, if cancelled donation checks are being displayed the Post and/or Ladies Auxiliary bank account number and signatures of officers should be blanked out to avoid potential theft.

NO ONE DOES MORE FOR VETERANS is more than just words; it is a commitment, a promise and a dedication to the goals and values of the VFW. Community service is one way we expose those goals and values to the public in a very real way. We are all about service, why not brag about it? We think we know how many hours and dollar values we donate but record keeping and reporting those numbers prove what we do and we don't make mistakes or skew those numbers.

There should be at least one Post in your Department that will be selected as a National Outstanding Community Service Post. Each Department will select at least one Post (depending on Department size) to receive the National Outstanding Community Service Post Award at the VFW National Convention.

The award includes a plaque inscribed with the name of the VFW Post and its Ladies Auxiliary (if applicable), a \$599 stipend to cover part of the Post representative's expenses to the National Convention, publication of the Post's name in the Convention program booklet and a street sign identifying this national award for the Post to put up in their community.

Your VFW Department is responsible for the selection criteria for this award and sending the name of the selected Post(s) to the National Programs Department by May 1 each year.

Public Servant Award Citation and Recognition

Every year the VFW recognizes outstanding and special heroes. These special dedicated public servants go the extra mile every day to serve the public and we should recognize their sacrifices and reward them in some small way for all they do. Recognition is appreciation, so let's appreciate all of them. Submit a Post candidate this year and don't let their accomplishments go unnoticed.

VFW National Emergency Medical Technician Public Servant Citation:

Any individual, who actively gives emergency medical treatment, provides rescue service or civil disaster assistance as a member of any public or volunteer company organized to give emergency medical care, provide rescue and civil disaster assistance to our nation's citizens.

VFW National Law Enforcement Public Servant Citation:

Any individual who serves in a municipal, county, state or federal unit tasked with enforcement of the laws pertaining to their area of responsibility. This award does not apply to individuals employed by private companies or security services.

VFW National Firefighters Public Servant Citation:

Any individual who actively fights fires as a member of any public or volunteer company organized to fight fires and give assistance to our nation's citizens.

Criteria for these awards – Candidates must have demonstrated:

- 1) Recognition by their colleagues or those they serve.
- 2) Consistent excellence in the performance of their duties
- Consistent dedication to their official responsibilities over a period of years and continuous growth in responsibilities and skills within their profession.

Documentation required for all Candidates

 Nomination letter containing the candidate's name, title, address, telephone and identifying the award for which the individual should be considered.

- 2) One (1) page resumé of the candidate's overall background.

In Memoriam Domenick A. Volpe

Domenick A. Volpe died on July 16, 2012 at the wonderful age of 95 leaving behind three devoted daughters, three grandchildren and five great grandchildren.

A vibrant man, Dom was a patriot whose love for his country with all its freedoms and opportunities carried him from the Normandy Invasion during World War II as a First Sergeant to the New York State Commandership of the Veterans of Foreign Wars of the United States (1977-78). An All-American Commander at every VFW level: State, District and County, his leadership and promotion of war veterans is legendary.

Dom was predeceased in death by his loving and loyal wife, Jean Mackenzie Volpe, in 2008; they both lived at Decatur House in Sandwich, Massachusetts in their later years, making new friends after having spent their lives and childhoods in Brooklyn, New York.

Dom Volpe was a self-made man who lived by his wits, intelligence and grit to make a good life for his family; he was a plucky entrepreneur in the food industry, who also worked for NYC Civil Defense, the federal Park Service, Bellevue Hospital and Appeal Printing. He worked two and three jobs at a time to make sure his family was well cared for, stressing the importance of a good education and individual responsibility.

Domenick was famous for his ever-present sense of humor, his superlative culinary and grilling skills and his commitment to his family. His proud daughters: Ann V. Daley, Walpole, Massachusetts; Janet V. Vailokaitis, Manhattan Beach, California; and Denise V. Sullivan, Cataumet, Massachusetts, as well as his extended family, learned a lot from the "Old Vet," God speed.

Military Funerals Get More Protection

President Obama signed the 'Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012' into law. This legislation will improve protections for family and friends at military funerals making it more difficult to disrupt and defame the final call of our fallen heroes.

The new legislation dictates that protests must be held at least 300 feet from military funerals and are prohibited two hours before or after a service. Congress agreed on these increases in protection after a more sweeping funeral protection legislation was struck down by the Supreme Court as a violation of the first amendment.

The Westboro Baptist Church, a Kansasbased organization, has vowed to defy the law continuing its despicable protests. State counter protests are affected by this new law, as well. The so-called 'counter protest groups' state the church fails to take into consideration the bikers, veterans and citizens blocking the church are there to pay their respects to the fallen warrior, not denigrate his or her memory and sacrifice and certainly not protest the ultimate sacrifice.

As quoted in the August 14, 2012 article in the *Huffington Post, "Two of these counterefforts drew national attention when large groups of people turned out in both Missouri and in Texas in an attempt to create "human walls" to shield attendees of military funerals from Westboro's demonstrations."* Obviously that human wall was composed of so many individuals desiring to pay their respects that the 'church protesters' were just crowded out. How ironic, the church protest*ers were outnumbered so they have to resort* to threats, intimidation and sacrilegious acts in an attempt to dishonor America's Best.





The Traveling Vietnam Wall

On Thursday, July 26, 2012, we were at the opening ceremonies at VFW Post 369 in Mexico, New York for the Vietnam Traveling Wall. It was a warm and rainy day. We all got drenched.
