## Gene Ratigliano Chief of Staff



Hello Comrades. Fall is upon us and it is a beautiful time of the year. I hope you are all taking the time to enjoy the changes of color and the wonders we are so fortunate to have here in the

east during the fall season. The leaves are changing and soon we will be faced with that inevitable white fluffy substance called snow. And even though we will be looking forward to another winter, as an organization we still have a job ahead of us. The membership gods are calling and as we move forward we need to continue to renew the members who have left the fold as well as think about the establishment of new posts in the Department. The Post Quartermaster can determine in his National Quartermaster Tools which members have lapsed their membership and the Department continues to receive calls about the establishment of new posts with many asking: "How do we do that?"

Firstly, there needs to be at least thirty-five (35) members interested in the formation of a new post of which twenty-five (25) need to be new members with an application submitted to the Commander-in-Chief. Once the Commander-in-Chief approves an application, the Commander must institute the new post within sixty (60) days of the date of the approval. If the new post is not instituted within the sixty-day period the approval may be rescinded.

Once the members wishing to form the new

post reach the required number of members for institution, the Department Commander will assign an Instituting Officer to oversee the establishment of the new post. The Instituting Officer will review all the documentation submitted by the members being mustered in and verify the eligibility of each applicant. After institution, election and installation of officers the Instituting Officer will submit a report to Department Headquarters. After 90 days, the Post Commander will verify the information necessary for the issuance of the charter and a charter will be issued by the Commander-in-Chief. Sec. 201 in the Manual of Procedure provides more detailed information on the Formation, Institution and Chartering of posts.

Even though in some areas posts are closing, there is still a need to establish a post when enough veterans are willing to do the hard work to establish another. There are many benefits to establishing a new post, but especially that of being a charter member. Charter members leave a legacy because their names will always be associated with that post whether it be 25 or 100 years down the road as long as that posts charter remains intact. It is a great honor to be a charter member and the names of those charter members will always be forever a part of the history of that post. Keep up the good work and don't forget to keep a member application in your wallet. You never know when you will meet that next veteran who will be our newest VFW member. # **LOST MAIL**

For months now, regular mail that is supposed to arrive at Department Headquarters has been going to the home addresses of Project and/or Department Chairs, Directors, Line Officers and every place but where it's supposed to go. Some critical mail destined for the Department Quartermaster or Adjutant ends up diverted to their homes. That increases the chances that mail is lost, misplaced or just plain late to arrive where all the data is compiled.

The consequence is, the critical reports and data that qualifies a post for All-State are not getting to the right place or persons or arriving past the due dates eliminating the chances of some posts to qualify at all. Some mail is even lost because officers don't realize the mail is for headquarters and not their round files.

All VFW mail must be sent to Department Headquarters, not to individual members homes. It is important that posts and members get all the credit they have earned so all required reports and information must go to: **Veterans of Foreign Wars, 69 Sand Creek Road, Albany, 12205** to the attention of the appropriate officer.

It's our responsibility to make sure posts and members aren't robbed of awards they deserve because of some misguided agenda, misinformation, and misunderstanding.

# DEPARTMENT OF NEW YORK REPRESENTED AT FALL NATIONAL LEGISLATIVE CONFERENCE IN WASHINGTON, D.C.

n September 23rd, Department Legislative Committee Members Joe Cognitore, Gene Ratigliano and David Czarnecki were part of the team which stormed Capitol Hill to communicate the VFW's legislative agenda to Congress. More than 70 members of the VFW National Legislative Committee and VFW leadership met with their Senators and Congressional Representatives to give their perspective on issues affecting veterans, the military and their families.

Issues which were brought to the attention at Capitol Hill by representatives included implementation of the Veterans Choice Act, employee accountability, the claims backlog and eliminating the one per cent Cost-of-Living Adjustment penalty for future members of the military. At the top of the list on the VFW agenda was ending Sequestration, and the arbitrary spending caps imposed by the Budget Control Act which is harming DOD and could potentially threaten the VA.

These issues continue to be on the forefront of the VFW's efforts to end sequestration and improve the care being given to our veterans by the VA. You can help and are strongly encouraged to continue the momentum of the conference by contacting your Senators and Congressmen to let them know what they can do to keep the faith with veterans and service members. You can also help by hosting as well as attending local Town Hall Meetings in your community.

# **STUDENT VETERANS ASSOCIATION**

Commander Biedrzycki has reissued a letter to all National Council Members asking them to assist in reaching out to the Student Veteran Association membership. With that in mind, I am asking our membership to step up efforts in this endeavor by using the following suggestions.

- 1.) Identify opportunities to speak to student veterans. Tell them how to access Department and Post Service Officers. OTI provides the training so let's use that knowledge.
- 2.) Offer them comradeship and the use of your Post facilities.
- 3.) Ask them to cooperate with you on community and veterans issues.
- 4.) Offer them assistance in conducting their events, celebrations and recognition ceremonies.
- 5.) Tell them about the VFW Legislative Fellowship Program and the ten fellowships that will be awarded. That means a trip to attend the National Legislative Conference in Washington DC from February 28th to March 2nd. A chance to meet legislatures and express their concerns on Veterans issues alongside our members. A chance to attend a meeting when our National Commander testifies before the Joint Congressional Veterans Committee. The VFW will pay for airfare, lodging and pay a stipend for expenses. The deadline to apply for these fellowships is October 31st. There are about 50 SVA chapters in New York. Adjutant Burke has sent out a notice on September 9th to all District Commanders concerning this subject. Apply at <u>WWW.vfw.org/studentfellowship</u>.
- 6.) Assist them in making community connections for mutual benefit.
