Quartermasters, there is a special manual for your position and you should download it for reference throughout your term of office. One major issue is bonding of the Liquid Assets of the Post or District. The Post Quartermaster is the chief financial officer of the Post. The Quartermaster is the custodian of all Post property and the officer responsible for safeguarding Post funds and property. The duties of the Quartermaster are set forth in **Section 218** (a) (5) of the Manual of Procedure. Qualify and secure a bond in a sum at least equal to the amount of the liquid assets for which they may be accountable in accordance with Section 703.

There will be Training for Quartermasters at the Department and Districts during the year. I cannot say it enough, **PLEASE ATTEND an OTI session near you**.

**Bonding**. There are too many Posts which believe the Post insurance company can provide a bond to cover the Quartermaster and anyone who handles money. Most of the time it is a surety policy and not a true bond. One key item, if it has a deductible or requires an arrest and police report, it may not be a true bond.

If your Post has a budget, those items up to the budget limit may be dispersed without an approval at a regular or specially called meeting. ALL expenses aside from budgeted items MUST BE voted on and approved at a regular or Special meeting before the bill is paid. We at headquarters are here to assist with any

concern which may arise. Call or email. Enjoy your summer.

As we move towards the upcoming elections cycle, I direct everyone's attention to Article VII, Sec. 702 of the VFW National Bylaws, which states, "No Post, County Council, District, Department or the National Organization, or any component part or member thereof, shall participate in any way in a campaign of a candidate for any partisan public office..." applies to fundraisers, endorsements, and the use of VFW facilities or names in any way that suggests the VFW is supporting a candidate.

The Post building may be rented or used by a political campaign for an event, and this is done the same way as with any other private group (e.g., through a rental agreement, without promotion or endorsement by the Post), this may be permissible, as long as:

• The Post does not advertise, promote, or sponsor the event.

• The event does not use VFW branding or materials.

• The Post does not show favoritism or exclusivity to one candidate or party.

• The Post ensures equal opportunity for other candidates to rent the space (if requested) The Commander and the Post membership must

The Commander and the Post membership must take great care to avoid giving the impression that the VFW is endorsing the candidate in any way. Always remember, if you're not sure, ask first. Yours in Comradeship, Ben Ben Thompson, PSC

At this juncture of the year there is not much to report on as we close the 2024-25 VFW year as we prepare and head to the National Convention in Columbus in August. As I write this article there are two days left in the membership year and this will be in your hands after the dead date of June  $30^{th}$ . As of this morning the Department is at 98.14% in membership and it is unlikely that we will reach our goal of 100% this year. Congratulations to those Commanders and Quartermasters along with your post members who worked hard to earn All-State recognition.

The Department's Veteran Service Officers have been incredibly busy over the last few years. A lot of this is due to the PACT Act going into effect in 2022. Amongst things, the PACT Act expanded eligibility, health conditions and awareness for Veterans. I ask that everyone continue to advocate for Veterans and make yourself aware of any legislation from local to national that impacts Veterans. Fiscal year 2023-2024 was a record setting year as far as money recouped for Veterans and eligible family members from VA compensation and pension claims. For FY 24-25, we are over \$15 million ahead of last year's pace with three months left to go in the fiscal year

Another reason our VSOs are so busy, we have expanded, and the word is getting out that we are open for business. Some National Veteran Service organizations have downsized their presence in New York State. With the expansion into New York City, we have gone from five full-time VSOs to nine, with a couple more in the works. We can reach out and provide better in-person services now in NYC. On a personal note, I would like to see our coverage in Central New York expanded. This takes money and hopefully we can get the message out to our state legislators that we provide a valuable service for Veterans and their families across the state.

The Service Officer are the ones supporting Veterans and their families to address military related toxic exposure. These are just one of the programs the service officers help veterans with.

On September 23, 2024, the Defense POW-MIA Accounting Agency (DPAA) identified the remains of



Private Harland J. Hennessey, missing WWII. from Private Hennessey entered the U.S. Army from New York and served in the 803<sup>rd</sup> Engineer Engineer Battalion, Aviation. He was stationed in the Philippines at the time of the Japanese invasion of the islands. Pvt. Hennessey was captured in Bataan following the American surrender, on April 9, 1942. After the surrender, the Japanese

began the forcible transfer of American and Filipino prisoners of war to various camps in central Luzon, at the northern end of the Philippines.

The largest of these camps was the notorious Cabanatuan Prison Camp. At its peak, Cabanatuan held approximately 8,000 American and Filipino prisoners of war that were captured during and after the Fall of Bataan. Camp overcrowding worsened with the arrival of Allied prisoners who had surrendered on Corregidor on May 6, 1942. Conditions at the camp were poor, with food and water extremely limited, leading to widespread outbreaks of malaria malnutrition and and dysentery. According to prison camp and other historical records Pvt. Hennessey died on November 1, 1942. He was reportedly buried in Common Grave 704 (CG704), but complications in the burial and recovery process precluded identifying his remains immediately following the war.

In 2018, as part of the Cabanatuan Project, the DPAA exhumed the Unknowns associated with CG704 for comparison to associated casualties. Laboratory analysis and the totality of the circumstantial evidence available established one set of remains as those of Pvt. Hennessey.

Private Hennessey is memorialized on the Walls of the Missing at the Manila American Cemetery in the Philippines.

You will be notified of Private Harland J. Hennessey's internment as the information becomes available.

As the newly appointed Department Poppy Chairperson I want to see how we will do next year as compared to this past year. In order to do so I tabulated what we did by District and this is the breakdown:

District 1—23 posts had 6 posts participate which is 26.1%, 3,500 poppies.

District 2—64 posts had 26 posts participate which is 40.6%, 34,500 poppies.

District 3—41 posts had 17 posts participate which is 41.5%, 26,500 poppies.

District 4-21 posts had 4 posts participate which is 19.0%, 4,000 poppies.

District 5—36 post had 7 posts participate which is 19.4%, 4,500 poppies.

District 6-34 posts had 13 posts participate which is 38.2%, 12,500 poppies.

District 7—19 posts had 5 posts participate which is 26.3%, 7,500 poppies.

District 8—22 posts had 6 posts participate which is 27.3%, 9,000 poppies.

District 9—14 posts had 2 posts participate which is 14.3%, 3,000 poppies.

District 10-24 posts had 14 posts participate which is 58.3%, 41,000 poppies.

District 11—27 posts had 14 posts participate which is 51.9%, 31,000 poppies.

I must say that we cannot compare districts to one another as each is unique in its make-up and character and wealth. The Department of NY had 3 posts purchase 10,000 poppies with one of those getting 11,000!

How did the Department do compared to all of the VFW? VFW National lists 5,553 posts and 6,010,830 poppies, I can't give you the number of posts from the rest of the nation that actually distributed poppies, while Department of NY lists 325 posts and 177,000 poppies purchased by 114 posts. I am sure that some posts still have poppies left over pre-COVID.

It would be nice if our newly elected District Commanders urged more posts in their district to participate. Remember that the funds donated are to be used only for fellow veterans in need and what area of our state does not have a few cases? I for one get a great feeling when I have issued checks from a relief fund to veterans in need. **The VFW, no one does more for veterans.**
