For that same period of time the total number of veterans, military members and their families supported was 13,076. The need does not go away.

The information, guidelines and regulations are always available. This may be on the Department website at: www.vfwny.com or the National web site at: www.vfw.org or the IRS. The VFW Stores have books of By-Laws, Manual of Procedures-Ritual Books or CD's available for anyone to purchase. Some local bookstores have the information available to download directly to your computer.

Quartermasters need to download the latest copy of the Quartermaster's Guide 2020-21 for their use during the year. This will, along with other material, will provide the necessary information to enable handling the duties of the Quartermaster considerably easier. The Quartermaster Guide Introduction is a quick overview of the duties and obligations the Quartermaster.

To access these and other documents and training material, please log in at VFW.org under "My VFW" to find the training and support for the links to the training and information library.

Recently, I have attended a couple of meetings where there was a considerable amount of disagreement about information from Department headquarters and about the National By-Laws and Manual of Procedure. In each case, the objections were due to not understanding the entire document and or the entire section of the By-Law they were referring to. In no case did anyone have the current or any copy of the By-Laws with them.

The solution is to read an entire document before objecting to a single sentence of the letter. The same holds true for the By-Laws, read the entire section before trying to pick a phrase or sentence out of text.

Knowledge and understanding comes from attending meeting, (post, county, District, Department and OTI sessions.

A couple of weeks ago I did send a letter to Governor Cuomo about his directive to lower the American Flag to half-staff "Indefinitely". While I truly sympathize with why he did it but is clearly outside of his purview to do. I am waiting a response, but also know the chances of that. Clearly the flag is not high on his priority.

The letter was sent out to the Districts and Posts but in case you

have not seen it, here it is below.

Please feel free to circulate it in your community. I will be sharing this with the media...keep your fingers crossed there is more interest than just us.

Please feel free to contact me about anything you feel needs to be addressed this legislative year. Remember, we are here to give voice to those who cannot. I cannot do it all alone, I need you!

Governor Andrew M. Cuomo,

I want to bring to your attention something that has many people talking and not in a positive way. I realize you are a busy man, but I was asked to bring this to your attention under the direction of Thomas Howard, Commander of the Veterans of Foreign Wars, Department of New York.

The pandemic has changed all our lives and a lot of families have been affected by it. I honestly believe, everyone has lost a family member, friend, or someone they know to this pandemic. As we look for the end to this difficult time, with hopeful optimism, it tends to wear on us. We look to our leaders to provide hope and guidance.

Our greatest symbol of hope, strength and unity has been brought to her knees — OUR American Flag. Respectfully, sir, never in history has she looked so defeated for so long, hanging at half-staff. A position normally reserved for those who gave their lives for this country during service as a principal figure in government or in our military. That power was given to you, the Governor of New York, by U.S. Flag Code, section 7(m) to honor those from this state who have fallen during their service. Again, respectfully, this section does not give you the power to lower the Unite States Flag outside of this section of the Flag Code. That directive is reserved for the President of the United Sates, alone.

Please don't miss understand me, I and many others understand your sympathy for those we have lost to this terrible virus, but what about the returning service members who died for this country, like Army Specialist Vincent Sebastian Iberria who died in Afghanistan on July 3, 2020? You directed the flag to "remain" at half-staff. While that was appreciated, it rang hollow.

On July 17th we lost a U.S. Congressman and staunch civilrights leader, Mr. John Lewis. On July 18th, the President ordered our American flag to half-staff in honor of Mr. Lewis, but, again, the honor is hollow in New York because she has been down on "PAUSE" since April 8th, 2020 at your directive of "Indefinitely". An order never in our Flag's history has been given by any President. Not during any wars, the great depression, civil rights movement or 9-11 has she been to her knees like you have illegally ordered. No, she has flown high and was the sign of hope the American people took solace in when they saw her to get through the tough times. We voted for you to lead our state through such time and you have, but this directive is illegal and hurtful to the moral of the people of New York.

Governor, if you have noticed, I have referred to our U.S. Flag as "her" or "she". That is because she represents a living nation, "We the People" of the United States, who live and die as Americans. Not just the people of New York. She is not just some piece of cloth with a pattern of red, white, and blue on her to be used. She is more than that, and as such, is due the simple respect of following the U.S. Flag Code so that she is always properly displayed, collectively for the people of this great nation.

The proper thing to do is lower the New York State flag to half-staff. It represents you and the people of New York. Plain and simple. You can leave our state's flag down until the pandemic is over, showing our sympathy here in New York. That is your right to do.

Governor Cuomo, on behalf of all U.S. Citizens, the military who defend her, and the veterans who gave us the Flag Code, I very respectfully ask that you return our American Flag to her rightful position at the top of her staff so that she can, once again, be the symbol of hope, strength and unity for the people of New York.

Should you receive a media inquiry, you should respond: "I have no authority to respond to your request". You should refer your question to the Department Adjutant.

As a direct result of the escalation of COVID-19 cases around the US and keeping the health and welfare of our members and officers a priority the State Commander Howard has issued DSO No. 13 which **Until further notice all Department Officers and Chairman's Travel is cancelled** and the Commander asks that you follow the Governors mandates.

I believe that we should begin to incorporate these capabilities into our meeting as soon as possible. That may be next month, year or ?. WE are still waiting for some of our Posts to use computers to start with, so I expect this to be an even slower start.

Please don't be that person who will assume that no one will do this, why bother. The decision to or not to is that of the membership, not the leadership! The opportunity should be offered. There is little or no expense, just the effort to notify and set it up.

- Headache
- · Loss of taste or smell
- A rash on skin, or discoloration of fingers or toes

Serious symptoms:

- · Difficulty breathing or shortness of breath
- Chest pain or pressure
- · Loss of speech of movement

Seek immediate medical attention if you have serious symptoms. Always call before visiting your doctor or health facility.

On average it takes 5–6 days from when someone is infected with the virus for symptoms to show, however it can take up to 14 days.

I am looking forward to talking to the District Commanders throughout this year as well as contacting the VA Hospitals within the Districts. Again with COVID-19 still here continue to be safe.

Please remember that Poppies may be distributed at any time of

the year, at any place where people are gathered, street fairs, Sporting Events, public gatherings.
